#### **Package Contents**

- RJ-11 to RJ-11 Cable with cable coupler

- Communication software

3-1 PCMCIA 33.6 Data/FAX/Voice Modem

#### **Additional features**

The IBM PCMCIA 33.6 Data/FAX/Voice modem, when used with communications software programs which support these features, can be used to do the following:

- Invoke AutoSync\*\*.
- Automatically dial calling card numbers
- Voice messaging

The modem automatically adjusts from asynchronous to synchronous data transmission, called AutoSync.

With AutoSync turned on, the modem automatically converts to synchronous communication when it is connected to a synchronous modem. This eliminates the need for an asynchronous-to-synchronous conversion device when connecting to a mainframe or other system requiring synchronous communications.

Your communications software must support AutoSync in order for you to use it. Your software will affect how the modem functions with AutoSync.

To activate AutoSync, do the following:

- Set S-Registers S19, S20, and S25 to the values you want to use
- Issue **AT&Q4S95=0**

After the **CONNECT** message appears, the modem waits a period of time determined by S25 before examining the condition of the DTR signal: if DTR is on, the modem begins synchronous operation; if DTR is off, the modem hangs up and returns to asynchronous operation.

AutoSync will stop under the following conditions:

- Any **AT&D***n* command
- Loss of carrier
- Ejecting the modem
- Cable disconnection

#### **Caller ID**

Your modem, when used with communications software that supports this feature, allows you to keep track of callers' names and telephone numbers. You must subscribe to Caller ID from your phone company.

#### **Automatic Credit Card Dialing**

Whenever you make a credit card call, your modem will detect the "bong" that sounds prior to entering your credit card number. When it detects this sound, the modem automatically enters your credit card number, placing the call. This is called "smart dialing".

To use the smart dial feature, enter a string similar to this:

#### ATDT <phone#>&<credit card#>

#### **Voice Messaging**

Your modem, when used with communications software that supports this feature, allows you to send and receive personal voice mail. If you have a multimedia computer, you can send greetings and record voice messages as you would with a standard answering machine, with several voice mailboxes on one system. You can even access your voice messages remotely.

#### Additional Information for Installing with Windows NT 4.0

- After power on, open Control Panel
- Double click Modems icon
- Install New Modem panel should appear on your screen
- Check don't detect modem
- Click NEXT
- Insert supplied Windows95 Installation diskette in diskette drive
- Click on OK
- Under Models, you should see IBM 33.6 Data-Fax-Voice Modem
- Remove diskette, click on NEXT
- Windows NT 4.0 will request you select a com port, select any one then click on **NEXT**.
- If NT says it is unable to add modem to com port, click **OK** and re-run modems from control panel but do NOT select **don't detect modem**. Windows NT 4.0 will then correctly assign the modem to a com port.

#### Vertifying OS/2 COM port setting

- Open System Setup in System folder.
- Double click on the **Plug-and-play** icon.
- You should see **modem configured in** the slot number the modem is in.
- To find out which COM port the modem is assigned to, select the slot and double click on it.
- This will display the COM port and IRQ ( interrupt ) that is assigned to the modem.

## Part 4: Cellular Communications

#### Introduction

Connecting your modem to a cellular telephone gives you freedom from land lines, enabling you to send data and faxes without being tied to a physical phone line. You can move from one network or cell to another and still use your phone.

Before you can use a cellular phone with your modem, you must obtain the correct Cellular cable. Cellular cables are provided for IBM by USRobotics\*\* parts service center.

The modem can support up to two cellular drivers, which support certain models of Motorola\*\*, Nokia\*\*, AT&T\*\*, Radio Shack\*\*, and other leading cellular phones. Simply plug in the cellular cable, and the modem will recognize the type of phone you plan to use.

#### What to Expect from Cellular Data Transmissions

Cellular mobility creates some conditions of which you should be aware:

- Cellular phones use radio frequencies for transmission, and are subject to the same signal impairments as are other radio devices. Your modem is designed to overcome this.
- Because cellular telephones use radio frequencies, they do not do any of the following:
  - Generate dial tones or busy signals
  - Send ring voltage back to the modem
  - Decode touch tone or pulse dial signals

Your modem is configured to overcome this.

- A large portion of the cellular voice channel is reserved for out-of-band signalling, reducing the bandwidth on the cellular network. This can result in distortion or signal loss. You cannot control this.
- Voice compression techniques on some cellular networks can cause loss of bandwidth, resulting in slower data transmission. You cannot control this.
- The mobile telephone exchange may send a signal over the control channel commanding the telephone to reduce its transmission power, possibly resulting in dropped data lines. You cannot control this.
- The mobile telephone exchange may send messages to, or request information from, the telephone on the voice channel while the data link is established. This can temporarily disrupt data communications or cause the line to be dropped. You cannot control this.

## To ensure that your transmission quality is as high as possible, do the following:

- Use cellular protocols whenever possible. These will be set up automatically on the modem when you plug in the Megahertz cellular direct connect cable. Always use error correction and data compression to receive and send the highest quality transmissions.
- Use cellular modem pools if available. Contact your cellular carrier or service provider to see if cellular modem pools are available in your area. This service is accessed by dialing the previs \*DATA (\*3282) before the number you are dialing.
- Be sure the signal is as strong as it can be. Refer to your cellular phone's manual for a description of signal strength, and an explanation of how to read the signal strength bars. If the signal is not strong enough to support a voice call, it will not handle data transmission.
  - Pull the antenna out to its full length and point it in several different directions until you find the strongest signal. Try putting the phone in a vertical position and moving it closer to a window. Never lay the phone on a metal surface during transmissions.
  - Keep in mind that large objects like mountains or even a car hood can cause the signal to be reflected back to you or block the signal from reaching the phone.
- Be sure the cellular phone's battery is fully charged while you are sending or receiving faxes or data.
  - If the low battery message blinks during transmission (signaling it is running out of power), disconnect the transmission, attach a fully charged battery, and redial.

#### **Automatic Cable Sensor**

When no cellular cable is inserted, the modem is in landline mode. When a cellular cable is inserted, a three-tone ascending beep will sound, the message **Motorola Cable Attached** or **Nokia Cable Attached** will appear (if you are in terminal mode), and the modem will automatically go into cellular mode.

If a cable is attached that the modem does not recognize, the message **Unrecognized Cable Attached** will appear if you are in terminal mode.

No AT command string is needed to put the modem into cellular mode. The initialization string is automatically sent when the cable is attached.

When the cellular cable is removed, the message **Cable has been Removed** will appear if you are in terminal mode and the modem will automatically return to land line mode.

#### **Connecting the Modem to a Cellular Phone**

If the cellular cable kit requires it, flash your modem to enable cellular functions.

Always connect the cables in the following order:

- 1. Insert the modem into the computer.
- 2. Be sure your computer is powered up.
- 3. Initialize the modem in the computer.
- 4. Enter your communications software package.

5. Connect the cellular phone cable to the phone. The phone's power should be off.

6. Connect the other end of the cellular cable to the modem. You will hear three ascending tones in rapid succession, indicating that the Cable Sensor recognizes the cable and the modem is configured for the phone. If your software is in terminal mode, the message **<Phone> Cable Attached** will appear.

7. Turn the cellular phone on, if modem has not already turned it on. If you have a digital cellular phone, switch it to analog mode (refer to your phone's user manual for instructions on how to do this). The phone is now ready to use.

The cellular phone connection looks like this:



#### **Using Cellular Protocols**

The modem is equipped with both ETC\*\* and MNP\*\* 10-EC cellular enhancements. If you are not sure what cellular protocols the modem with which you are connecting supports, set **S79=1** to set the startup rate at 4800bps. The transmission speed between the modems will adjust during the call to the fastest speed that produces the most stable transmission.

#### MNP 10-EC and ETC

The purpose of MNP 10-EC and ETC cellular protocols is to combat particularly harsh line conditions that can arise during cellular and rural transmissions to produce optimum cellular performance.

MNP 10-EC is the default cellular protocol for your modem. MNP 10-EC supports LAP-M and MNP error correction protocols. When the modem connects with LAP-M error correction and has MNP 10-EC enabled, the protocol reported is LAP-M-EC (if the protocol result code reporting option is enabled). When the modem connects with MNP error correction and has MNP 10-EC enabled, the protocol reported is ALT-EC.

Both MNP 10-EC and ETC offer the following additional features:

- Improves the initial connection success rate.
- Automatically calculates optimal transmission speeds to compensate for cellular telephone signal distortion. This is done in the following categories:
  - The modem connection begins at the optimal speed that will ensure a strong connection, then moves to the highest possible speed during transmission.
  - A reliable link is established during noisy call setups.
  - Transmission speeds are adjusted continuously throughout the connection, supplying the highest possible speed with the greatest reliability that the line can support at any time.
  - Link and transmission performance under adverse conditions are greatly improved. Errors during transmission are detected and the packets resent.
  - Signal line conditioning

#### **Connecting to the Internet Over Cellular**

It is highly recommended that you connect to your Internet provider using a landline connection. Most Internet providers are not set up to support and maintain a cellular connection.

If you need to connect to an Internet provider with a cellular phone system, contact your local carrier to see if they provide a cellular modem pool (usually by dialing \*DATA (\*3282) before the number you are dialing).

If so, follow your carrier's instructions for connecting with the modem pool. Contact your Internet provider through the modem pool.

If not, carefully follow the recommended procedures to connect your cellular phone to the modem.

#### Dialing

Cellular dialing functions work the same as landline functions

If you are dialing manually and you do not require a Personal ID Number (PIN) and your phone number is 555-5555, enter

#### ATDT 5555555

If you are dialing manually and your cellular phone requires that you enter a PIN and your PIN number 1234, enter the phone number, five commas (you may need fewer or more commas, depending on your system. Each comma represents a two-second delay), an exclamation point, then the PIN number. For example, if your PIN number is 1234, enter

#### ATDT 5555555,,,,,!1234

Enter these numbers into a dialing directory the same way as they are shown above.

When the modem connection has been established using the default protocols, the protocol message will be **LAP-M-EC**, indicating the modem is using LAP-M error correction and MNP10-EC cellular enhancements.

### Part 5: Testing Your Modem

Refer to the Application Software's Installation Manual to load the communications software you will be using.

- 1. Turn on your computer.
- 2. Start your communication software and be sure it is in the command mode. This is also known as terminal mode.
- 3. Setup your communication software to 19200 and the communication port your modem is using.
- 4. If the port opened properly, go to the next step. Otherwise, check if you have any other communication software trying to use the same port. If so, close that software. If not, switch to a different COM port.
- 5. Type **AT&F** and press **enter**, you should see an **OK** response. If nothing happened at this point, this indicates that the modem is not getting the proper IRQ.
- 6. Type AT\N1 and press enter
- 7. Type ATE1 and press enter
- 8. Type ATS18=n and press enter

NOTE: n is the number of seconds (30-255) you want the test to last.

- 9. Type **AT&T1** press **enter**. You should see **CONNECT nnnnn** (n is the connect speed you selected) displayed on your screen. After the CONNECT message, the modem is in the data mode. You can type any character on your keyboard and see them displayed on your screen.
- 10. When the time you specified in register S18 expires, you see **OK** displayed on your screen.
- 11. Type **AT&F** and press **enter**, you should see an **OK** response on your screen.

#### **Dial Tone Test**

- 1. Turn on your computer.
- 2. Start your communication software and be sure it is in the command mode. This is also known as terminal mode.
- 3. Setup your communication software to the communication port your modem is using.
- 4. Type **ATZ** and press **Enter**.

Typing this command sets the modem to the default values. Your modem responds by displaying **OK** on your screen.

5. Type **ATL3** and press **Enter**.

Typing this command increases the volume level at the modem speaker. Your modem responds by displaying **OK** on your screen.

6. Type **ATD** and press **Enter**.

You should hear a dial tone from the modem speaker.

7. Press Enter.

You should no longer hear the dial tone. Your modem responds by displaying **NO Carrier** on your screen.
