Σημαντικές οδηγίες σχετικά με την ασφάλεια

Οι πληροφορίες αυτές μπορούν να σας βοηθήσουν να χρησιμοποιείτε τον προσωπικό σας υπολογιστή IBM[®] με ασφάλεια. Ακολουθήστε και φυλάξτε όλες τις πληροφορίες που παρέχονται μαζί με τον υπολογιστή IBM. Οι πληροφορίες που περιέχονται σε αυτό το έγγραφο δεν τροποποιούν τους όρους της σύμβασης αγοράς που συνάψατε ούτε τη Δήλωση Περιορισμένης Εγγύησης της IBM.

Η ασφάλεια των πελατών είναι σημαντική για την IBM. Τα προϊόντα μας είναι σχεδιασμένα να είναι ασφαλή και αποτελεσματικά. Ωστόσο, οι προσωπικοί υπολογιστές είναι ηλεκτρονικές συσκευές. Τα καλώδια ρεύματος, οι μετασχηματιστές και άλλα εξαρτήματά τους μπορούν να δημιουργήσουν κινδύνους που θα μπορούσαν να έχουν ως αποτέλεσμα την πρόκληση τραυματισμών ή ζημιών, ειδικά σε περίπτωση κακής χρήσης τους. Για να μειώσετε αυτούς τους κινδύνους, ακολουθήστε τις οδηγίες που παρέχονται με το προϊόν σας, δώστε σημασία σε όλες τις προειδοποιήσεις στο προϊόν και στις οδηγίες λειτουργίας και διαβάστε προσεκτικά όλες τις πληροφορίες που περιέχονται σε αυτό το έγγραφο. Ακολουθώντας προσεκτικά τις πληροφορίες που περιέχονται σε αυτό το έγγραφο και παρέχονται με το προϊόν σας, μπορείτε να συμβάλετε στην προστασία σας από κινδύνους και να δημιουργήσετε ένα ασφαλέστερο υπολογιστικό περιβάλλον εργασίας.

Σημείωση: Οι πληροφορίες αυτές περιέχουν αναφορές σε μετασχηματιστές και μπαταρίες. Πέραν των φορητών προσωπικών υπολογιστών, η IBM παρέχει ορισμένα προϊόντα (όπως π.χ. ηχεία και οθόνες) με εξωτερικούς μετασχηματιστές. Αν έχετε ένα τέτοιο προϊόν, οι πληροφορίες αυτές ισχύουν για το προϊόν σας. Επιπρόσθετα, ο υπολογιστής σας μπορεί να περιέχει μια εσωτερική μπαταρία σε μέγεθος νομίσματος, η οποία τροφοδοτεί με ηλεκτρικό ρεύμα το ρολόι του συστήματός σας ακόμα και όταν η μηχανή είναι αποσυνδεδεμένη. Επομένως οι πληροφορίες σχετικά με την ασφάλεια των μπαταριών ισχύουν για όλους τους υπολογιστές.

Συνθήκες που πρέπει να αντιμετωπίζονται άμεσα

Τα προϊόντα μπορεί να υποστούν ζημίες λόγω κακής χρήσης ή αμέλειας. Σε ορισμένες περιπτώσεις, οι ζημίες μπορεί να είναι τόσο σοβαρές ώστε το προϊόν να μην πρέπει να χρησιμοποιηθεί ξανά έως ότου επιθεωρηθεί και, αν είναι αναγκαίο, επισκευαστεί από εξουσιοδοτημένο τεχνικό.

Όπως και με κάθε ηλεκτρονική συσκευή, πρέπει να προσέχετε το προϊόν όταν είναι αναμμένο. Σε πολύ σπάνιες περιπτώσεις, μπορεί να αισθανθείτε μια οσμή ή να παρατηρήσετε καπνό ή σπίθες προερχόμενες από τη μηχανή σας. Ή μπορεί να ακούσετε ήχους που υποδηλώνουν κάποιο πρόβλημα. Οι συνθήκες αυτές μπορεί απλώς να σημαίνουν ότι έχει υποστεί βλάβη κάποιο εσωτερικό εξάρτημα, με ασφαλή και ελεγχόμενο τρόπο. Μπορεί όμως και να υποδηλώνουν πιθανό πρόβλημα ασφάλειας. Ωστόσο, μη ρισκάρετε και μην προσπαθήσετε να διαγνώσετε το πρόβλημα μόνος σας.

Ελέγχετε συχνά τον υπολογιστή σας και τα εξαρτήματά του, ώστε να εντοπίζετε τυχόν ζημίες, φθορά ή ενδείξεις κινδύνου. Αν υπάρχει οποιαδήποτε αβεβαιότητα σχετικά με την κατάσταση ενός εξαρτήματος, μη χρησιμοποιήσετε το προϊόν. Επικοινωνήστε με το IBM HelpCenter[®] ή τον κατασκευαστή του προϊόντος για οδηγίες σχετικά με τον έλεγχο του προϊόντος και, αν είναι απαραίτητο, την επισκευή του. Οι τηλεφωνικοί αριθμοί για το IBM HelpCenter που εξυπηρετεί τη χώρα σας βρίσκονται στην ενότητα Telephone numbers αυτού του εγχειριδίου.

Στην απίθανη περίπτωση που παρατηρήσετε οποιαδήποτε από τις συνθήκες που αναφέρονται παρακάτω, ή αν έχετε οποιεσδήποτε ανησυχίες σχετικά με την ασφάλεια του προϊόντος, πάψτε να το χρησιμοποιείτε και αποσυνδέστε το από την πρίζα και από τις τηλεπικοινωνιακές γραμμές έως ότου μιλήσετε με το IBM HelpCenter για περαιτέρω καθοδήγηση.

- Καλώδια ρεύματος, φις, μετασχηματιστές, επεκτάσεις καλωδίων, συσκευές προστασίας από υπερτάσεις ή τροφοδοτικά που έχουν κοπεί, ραγίσει, σπάσει ή υποστεί ζημίες.
- Ενδείξεις υπερθέρμανσης, καπνού, σπίθας ή φωτιάς.
- Ζημίες σε μια μπαταρία (όπως ρωγμές ή παραμόρφωση), αποφόρτιση μπαταρίας ή συσσώρευση ξένων ουσιών επάνω στη μπαταρία.
- Περίεργοι ήχοι ή δυνατή οσμή προερχόμενη από το προϊόν.
- Ενδείξεις ότι έχει χυθεί υγρό ή έχει πέσει κάποιο αντικείμενο επάνω στον υπολογιστή, το καλώδιο ρεύματος ή το μετασχηματιστή.
- Έκθεση του υπολογιστή, του καλωδίου ρεύματος ή του μετασχηματιστή σε νερό.
- Πτώση του προϊόντος ή άλλες ζημίες στο προϊόν.
- Μη κανονική λειτουργία του προϊόντος όταν ακολουθείτε τις οδηγίες λειτουργίας.

Σημείωση: Αν παρατηρήσετε τέτοιες συνθήκες σε προϊόν μη-IBM (π.χ. μια επέκταση καλωδίου), πάψτε να χρησιμοποιείτε αυτό το προϊόν έως ότου επικοινωνήσετε με τον κατασκευαστή του προϊόντος για περαιτέρω οδηγίες, ή έως ότου προμηθευτείτε κατάλληλο προϊόν αντικατάστασης.

Γενικές οδηγίες ασφάλειας

Τηρείτε πάντα τις ακόλουθες προφυλάξεις για να μειώσετε τον κίνδυνο τραυματισμού και πρόκλησης ζημιών.

Συντήρηση

Μην επιχειρήσετε να κάνετε συντήρηση ενός προϊόντος μόνος σας, εκτός αν σας ζητηθεί συγκεκριμένα από το IBM HelpCenter. Χρησιμοποιείτε μόνο εξουσιοδοτημένο από την IBM παροχέα υπηρεσιών, εγκεκριμένο για την επισκευή του συγκεκριμένου προϊόντος.

Σημείωση: ορισμένα εξαρτήματα μπορούν να αναβαθμιστούν ή να αντικατασταθούν από τον πελάτη. Τα εξαρτήματα αυτά ονομάζονται Αντικαθιστώμενες από τον Πελάτη Μονάδες (Customer Replaceable Units - CRU). Η IBM προσδιορίζει ρητώς ποια εξαρτήματα είναι CRU και παρέχει τεκμηρίωση με οδηγίες όταν ενδείκνυται η εγκατάστασή τους από τον πελάτη. Πρέπει να ακολουθείτε πιστά αυτές όλες οδηγίες όταν αντικαθιστάτε CRU. Να βεβαιώνεστε πάντα ότι έχετε σβήσει και αποσυνδέσει το προϊόν από οποιαδήποτε πηγή ρεύματος πριν επιχειρήσετε να πραγματοποιήσετε την αντικατάσταση. Για οποιεσδήποτε ερωτήσεις ή διευκρινίσεις, επικοινωνήστε με το IBM HelpCenter.

Καλώδια ρεύματος και μετασχηματιστές

Χρησιμοποιείτε μόνο τα καλώδια ρεύματος και τους μετασχηματιστές που παρέχονται από τον κατασκευαστή του προϊόντος.

Ποτέ μην τυλίγετε ένα καλώδιο ρεύματος γύρω από το μετασχηματιστή ή άλλο αντικείμενο. Αν το κάνετε, μπορεί το καλώδιο να καταπονηθεί, με αποτέλεσμα να φθαρεί, να κοπεί ή να μπλεχτεί. Αυτό μπορεί να είναι επικίνδυνο.

Να εξασφαλίζετε πάντα ότι τα καλώδια ρεύματος δεν περνούν από σημεία όπου μπορεί να πατηθούν, να γίνουν αιτία να σκοντάψει κάποιος ή να τρυπηθούν από αντικείμενα.

Να προστατεύετε τα καλώδια και τους μετασχηματιστές από υγρά. Για παράδειγμα, μην αφήνετε τα καλώδια ή τους μετασχηματιστές κοντά σε νεροχύτες, μπανιέρες ή τουαλέτες, ή σε δάπεδα που καθαρίζονται με υγρά καθαριστικά. Τα υγρά μπορούν να προκαλέσουν βραχυκύκλωμα, ειδικά αν το καλώδιο ή ο μετασχηματιστής έχει φθαρεί λόγω κακής χρήσης. Τα υγρά μπορούν επίσης να προκαλέσουν σταδιακή διάβρωση των ακροδεκτών του καλωδίου ρεύματος ή/και του μετασχηματιστή, κάτι που μπορεί να προκαλέσει υπερθέρμανση.

Πάντα να συνδέετε τα καλώδια ρεύματος και τα καλώδια σήματος με τη σωστή σειρά και να εξασφαλίζετε ότι όλα τα καλώδια ρεύματος έχουν συνδεθεί πλήρως και με ασφάλεια στις πρίζες.

Μη χρησιμοποιήσετε οποιονδήποτε μετασχηματιστή στον οποίο υπάρχουν ενδείξεις διάβρωσης στους ακροδέκτες εισόδου εναλλασσομένης τάσης ή/και ενδείξεις υπερθέρμανσης (π.χ. παραμορφωμένο πλαστικό) στην είσοδο εναλλασσόμενης τάσης ή σε οποιοδήποτε σημείο του μετασχηματιστή. Μη χρησιμοποιείτε οποιαδήποτε καλώδια ρεύματος αν υπάρχουν ενδείξεις διάβρωσης ή υπερθέρμανσης στους ακροδέκτες οποιουδήποτε από τα δύο άκρα τους ή αν το καλώδιο έχει υποστεί οποιεσδήποτε φθορές.

Επεκτάσεις καλωδίων και σχετικές συσκευές

Εξασφαλίστε ότι οι επεκτάσεις καλωδίων, οι συσκευές προστασίας από υπερτάσεις, οι μονάδες αδιάλειπτης παροχής ρεύματος και τα πολύπριζα που χρησιμοποιείτε καλύπτουν τις ηλεκτρικές προδιαγραφές του προϊόντος. Ποτέ μην υπερφορτώνετε αυτές τις συσκευές. Αν χρησιμοποιηθούν πολύπριζα, το φορτίο δεν πρέπει να υπερβαίνει τις προδιαγραφές του πολύπριζου. Για οποιεσδήποτε ερωτήσεις σχετικά με τα ηλεκτρικά φορτία και τις προδιαγραφές, συμβουλευτείτε έναν ηλεκτρολόγο.

Φις και πρίζες

Αν κάποια πρίζα που σκοπεύετε να χρησιμοποιήσετε με τον υπολογιστή έχει ενδείξεις ζημιών ή διάβρωσης, μην τη χρησιμοποιήσετε έως ότου αντικατασταθεί από ηλεκτρολόγο.

Μη λυγίζετε ή τροποποιείτε το φις. Αν το φις έχει υποστεί ζημίες, επικοινωνήστε με τον κατασκευαστή για να το αντικαταστήσετε.

Ορισμένα προϊόντα έχουν φις τριών ακροδεκτών. Το φις αυτό μπορεί να συνδεθεί μόνο σε γειωμένη ηλεκτρική πρίζα. Αυτό γίνεται για λόγους ασφάλειας. Μην παρακάμψετε αυτή την προφύλαξη επιχειρώντας να συνδέσετε την πρίζα σε μη γειωμένη πρίζα. Αν δεν μπορείτε να συνδέσετε τος φις στην πρίζα, επικοινωνήστε με έναν ηλεκτρολόγο για να προμηθευτείτε έναν εγκεκριμένο προσαρμογέα ή για να αντικαταστήσετε την πρίζα με άλλη, κατάλληλη πρίζα. Ποτέ μην υπερφορτώνετε μια πρίζα. Το συνολικό φορτίο του συστήματος δεν πρέπει να υπερβαίνει το 80% του φορτίου που προβλέπεται από τις προδιαγραφές του κυκλώματος διακλάδωσης. Για οποιεσδήποτε ερωτήσεις σχετικά με τα ηλεκτρικά φορτία και τις προδιαγραφές του κυκλώματος διακλάδωσης, συμβουλευτείτε έναν ηλεκτρολόγο.

Βεβαιωθείτε ότι η πρίζα ρεύματος που χρησιμοποιείτε είναι σωστά καλωδιωμένη, εύκολα προσβάσιμη και βρίσκεται κοντά στον εξοπλισμό. Μην τεντώνετε τα καλώδια ρεύματος με τρόπο που μπορεί να προκαλέσει φθορά στα καλώδια.

Συνδέετε και αποσυνδέετε τον εξοπλισμό από την πρίζα με προσοχή.

Μπαταρίες

Όλοι οι προσωπικοί υπολογιστές IBM περιέχουν μια μη μεταφορτίσιμη μπαταρία που παρέχει ηλεκτρικό ρεύμα στο ρολόι του συστήματος. Επίσης, πολλά φορητά προϊόντα, όπως π.χ. φορητοί προσωπικοί υπολογιστές Thinkpad, χρησιμοποιούν πακέτο επαναφορτίσιμων μπαταριών για την παροχή ρεύματος στο σύστημα όταν δεν είναι συνδεδεμένο σε πρίζα. Οι μπαταρίες που παρέχονται από την IBM για χρήση με το προϊόν σας έχουν υποβληθεί σε δοκιμές συμβατότητας και πρέπει να αντικαθίστανται μόνο με εγκεκριμένες από την IBM μπαταρίες. Ποτέ μην επιχειρήσετε να ανοίξετε ή να επισκευάσετε μια μπαταρία. Μη συνθλίψετε, τρυπήσετε ή κάψετε μπαταρίες και μη βραχυκυκλώσετε τα μεταλλικά σημεία επαφής. Μην εκθέσετε τη μπαταρία σε νερό ή άλλα υγρά. Η επαναφόρτιση του πακέτου μπαταριών πρέπει να γίνεται μόνο σύμφωνα με τις οδηγίες που περιλαμβάνονται στην τεκμηρίωση του προϊόντος.

Η κακή χρήση ή ο κακός χειρισμός μπαταριών μπορεί να προκαλέσει υπερθέρμανση της μπαταρίας, η οποία μπορεί να έχει ως αποτέλεσμα την έκλυση αερίων ή φλόγας από τη μπαταρία. Αν η μπαταρία σας έχει υποστεί βλάβη, ή παρατηρήσετε οποιαδήποτε διαρροή από τη μπαταρία ή παρουσία ξένων υλικών στα άκρα της μπαταρίας, πάψτε να τη χρησιμοποιείτε και αντικαταστήστε τη με καινούργια από τον κατασκευαστή της μπαταρίας.

Οι μπαταρίες μπορεί να υποστούν βλάβη όταν παραμένουν αχρησιμοποίητες για μεγάλες χρονικές περιόδους. Για ορισμένες επαναφορτίσιμες μπαταρίες (και ειδικά για μπαταρίες λιθίου-ιόντων), η παραμονή της μπαταρίας εκτός χρήσης σε κατάσταση αποφόρτισης μπορεί να αυξήσει τον κίνδυνο βραχυκύκλωσης της μπαταρίας, η οποία μπορεί να μικρύνει τη διάρκεια ζωής της μπαταρίας, αλλά και να αποτελέσει κίνδυνο για την ασφάλεια. Μην αφήνετε τις επαναφορτίσιμες μπαταρίες λιθίου-ιόντων να αποφορτίζονται πλήρως και μην τις αποθηκεύετε σε κατάσταση αποφόρτισης.

Θερμότητα και εξαερισμός προϊόντος

Οι υπολογιστές παράγουν θερμότητα όταν είναι αναμμένοι και κατά τη φόρτιση των μπαταριών. Οι φορητοί προσωπικοί υπολογιστές παράγουν σημαντική ποσότητα θερμότητας λόγω του μικρού τους μεγέθους. Τηρείτε πάντα τις ακόλουθες προφυλάξεις:

- Μην αφήνετε τη βάση του υπολογιστή σε επαφή με το μηρό ή άλλο μέρος του σώματός σας για μεγάλο χρονικό διάστημα όταν είναι σε λειτουργία ο υπολογιστής ή φορτίζεται η μπαταρία. Ο υπολογιστής παράγει κάποια θερμότητα κατά τη διάρκεια της κανονικής λειτουργίας του. Η παρατεταμένη επαφή με το σώμα μπορεί να προκαλέσει δυσφορία ή ακόμα και εγκαύματα.
- Μη χρησιμοποιείτε τον υπολογιστή ή φορτίζετε την μπαταρία κοντά σε εύφλεκτα υλικά ή σε εκρηκτικό περιβάλλον.
- Οι σχισμές εξαερισμού, οι ανεμιστήρες ή/και οι ψύκτες του προϊόντος παρέχονται για σκοπούς ασφάλειας, άνεσης και αξιόπιστης λειτουργίας. Τα εξαρτήματα αυτά μπορεί να μπλοκαριστούν κατά λάθος αν το προϊόν τοποθετηθεί επάνω σε κρεβάτι, καναπέ, χαλί ή άλλη ευέλικτη επιφάνεια. Ποτέ μην μπλοκάρετε, καλύπτετε ή απενεργοποιείτε αυτά τα εξαρτήματα.

Ασφάλεια των μονάδων CD και DVD


Οι μονάδες CD και DVD περιστρέφουν δίσκους με μεγάλη ταχύτητα. Αν κάποιο CD ή DVD έχει ρωγμές ή άλλη φυσική ζημία, μπορεί να σπάσει ή να διαλυθεί κατά τη χρήση της μονάδας CD. Για να προστατευθείτε από πιθανό τραυματισμό σε τέτοια περίπτωση και να μειώσετε το κίνδυνο βλάβης της μηχανής σας, κάντε τα ακόλουθα:

- Αποθηκεύετε πάντα τους δίσκους CD/DVD στην αρχική τους συσκευασία.
- Αποθηκεύετε πάντα τους δίσκους CD/DVD μακριά από τις ακτίνες του ήλιου και μακριά από πηγές θερμότητας.
- Αφαιρείτε τους δίσκους CD/DVD από τον υπολογιστή όταν δεν χρησιμοποιούνται.
- Μη λυγίζετε τους δίσκους CD/DVD και μην τους βάζετε βίαια μέσα στον υπολογιστή ή στη θήκη τους.
- Ελέγχετε τους δίσκους CD/DVD πριν από κάθε χρήση για να βεβαιωθείτε ότι δεν έχουν ρωγμές. Μη χρησιμοποιείτε δίσκους που έχουν ρωγμές ή άλλες ζημίες.

Πρόσθετες πληροφορίες ασφάλειας



Το ηλεκτρικό ρεύμα στα καλώδια ρεύματος, τηλεφώνου και επικοινωνίας είναι επικίνδυνο. Για να αποφύγετε τον κίνδυνο ηλεκτροπληξίας, όταν εγκαθιστάτε, μετακινείτε ή ανοίγετε τα καλύμματα του προϊόντος ή των προσαρτημένων συσκευών, συνδέετε και αποσυνδέετε τα καλώδια όπως περιγράφεται παρακάτω. Αν παρέχεται τριαγωγικό καλώδιο ρεύματος με αυτό το προϊόν, πρέπει να συνδεθεί σε σωστά γειωμένη πρίζα.





Μειώστε τον κίνδυνο πυρκαγιάς και ηλεκτροπληξίας τηρώντας πάντα τις βασικές προφυλάξεις, όπως:

- Μη χρησιμοποιείτε τον υπολογιστή μέσα ή κοντά σε νερό.
- Κατά τη διάρκεια καταιγίδας:
 - Μη χρησιμοποιείτε τον υπολογιστή σας με καλωδιακή τηλεφωνική σύνδεση.
 - Μη συνδέετε ή αποσυνδέετε το καλώδιο από την τηλεφωνική υποδοχή στον τοίχο.

ΚΙΝΔΥΝΟΣ: Αποθήκευση του πακέτου επαναφορτίσιμων μπαταριών

Το πακέτο μπαταριών πρέπει να αποθηκεύεται σε θερμοκρασία δωματίου, φορτισμένο σε ποσοστό περίπου 30 - 50 % της χωρητικότητάς του. Συνιστούμε το πακέτο μπαταριών να φορτίζεται μία φορά ετησίως, ώστε να αποφεύγεται η υπερβολική αποφόρτισή του.

Αν το πακέτο επαναφορτίσιμων μπαταριών δεν αντικατασταθεί με το σωστό τρόπο, υπάρχει κίνδυνος έκρηξης. Το πακέτο μπαταριών περιέχει μικρή ποσότητα επιβλαβών ουσιών. Για να αποφύγετε τυχόν τραυματισμό:

- Αντικαταστήστε τη μπαταρία μόνο με μπαταρία του προτεινόμενου από την IBM τύπου.
- Κρατήστε το πακέτο μπαταριών μακριά από φωτιά.
- Μην το εκθέσετε σε νερό ή βροχή.
- Μην επιχειρήσετε να το αποσυναρμολογήσετε.
- Μην το βραχυκυκλώσετε.
- Κρατήστε το μακριά από παιδιά.

Μην πετάτε το πακέτο μπαταριών σε απορρίμματα που καταλήγουν σε χωματερές ή χώρους υγειονομικής ταφής απορριμμάτων. Η απόρριψη της μπαταρίας πρέπει να γίνεται σύμφωνα με τις τοπικές διατάξεις ή κανονισμούς και τις προδιαγραφές ασφάλειας της εταιρείας σας.

Αν η εφεδρική μπαταρία δεν αντικατασταθεί με το σωστό τρόπο, υπάρχει κίνδυνος έκρηξης.



You can also use the Access IBM button to interrupt the startup sequence of your computer and start the IBM Rescue and Recovery. If Windows does not start correctly, press the Access IBM button during the startup sequence of your computer and start the IBM Rescue and Recovery. Use this area to run diagnostics, restore your backups (assuming you have made backups using IBM Rapid Restore Ultra), restore to factory contents (i.e., what was there when you received your computer), start a utility that enables you to change your startup sequence, and get essential system information, and start the IBM BIOS Setup Utility where you can check and change BIOS settings.



Caring for your ThinkPad computer

Though your computer is designed to function reliably in normal work environments, you need to use common sense in handling it. By following these important tips, you will get the most use and enjoyment out of your computer.

Important tips:

Be careful about where and how you work

- Do not leave the base of your computer in contact with your lap or any part of your body for an extended period when the computer is functioning or when the battery is charging. Your computer dissipates some heat during normal operation. This heat is a function of the level of system activity and battery charge level. Extended contact with your body, even through clothing, could cause discomfort or, eventually, a skin burn.
- Place liquids away from your computer to avoid spills, and keep your computer away from water (to avoid the danger of electrical shock).
- Store packing materials safely out of the reach of children to prevent the risk of suffocation from plastic bags.
- Keep your computer away from magnets, activated cellular phones, electrical appliances, or speakers (within 13 cm/5 in).
- Avoid subjecting your computer to extreme temperatures (below 5°C/41°F or above 35°C/95°F).

Be gentle with your computer

- Avoid placing any objects (including paper) between the display and the keyboard or under the keyboard.
- Do not drop, bump, scratch, twist, hit, vibrate, push or place heavy objects on your computer, display, or external devices.
- Your computer display is designed to be opened and used at an angle slightly greater than 90 degrees. Do not open the display beyond 180 degrees, as this might damage the computer hinge.

Carry your computer properly

- Before moving your computer, be sure to remove any media, turn off attached devices, and disconnect cords and cables.
- Be sure your computer is in standby or hibernation mode, or turned off, before moving it. This will prevent damage to the hard disk drive and data loss.
- When picking up your open computer, hold it by the bottom. Do not pick up or hold your computer by the display.

• Use a quality carrying case that provides adequate cushion and protection. Do not pack your computer in a tightly packed suitcase or bag.

Handle storage media and drives properly

- Avoid inserting diskettes at an angle and attaching multiple or loose diskette labels, as these can lodge in the drive.
- If your computer comes with an optical drive such as a DVD, or CD-RW/DVD drive, do not touch the surface of a disc or the lens on the tray.
- Wait until you hear the CD or DVD click into the center pivot of the optical drive such as a DVD, or CD-RW/DVD drive before closing the tray.
- When installing your hard disk, diskette, DVD, or CD-RW/DVD drive, follow the instructions shipped with your hardware, and apply pressure only where needed on the device. See Access IBM, your on-board help system, for information on replacing your hard disk drive (open Access IBM by pressing the Access IBM button.).

Take care in setting passwords

• Remember your passwords. If you forget a supervisor or hard disk password, IBM will not reset it, and you might have to replace your system board or hard disk drive.

Other important tips

- Your computer modem might use only an analog telephone network, or public-switched telephone network (PSTN). Do not connect the modem to a PBX (private branch exchange) or any other digital telephone extension line because this could damage your modem. Analog phone lines are often used in homes, while digital phone lines are often used in hotels or office buildings. If you are not sure which kind of phone line you are using, contact your telephone company.
- Your computer might have both an Ethernet connector and a modem connector. If so, be sure to connect your communication cable to the correct one, so your connector is not damaged. See Access IBM, your on-board help system, for information on the location of these connectors (press the Access IBM button to open Access IBM).
- Register your ThinkPad products with IBM (refer to the Web page: www.ibm.com/pc/register). This can help authorities return your computer to you if it is lost or stolen. Registering your computer also enables IBM to notify you about possible technical information and upgrades.
- Only an authorized IBM ThinkPad repair technician should disassemble and repair your computer.
- Do not modify or tape the latches to keep the display open or closed.

- Take care not to turn your computer over while the ac adapter is plugged in. This could break the adapter plug.
- Turn off your computer if you are replacing a device in a device bay, or else verify that the device is warm-or hot-swappable.
- If you exchange drives in your computer, reinstall the plastic bezel faces (if supplied).
- Store your external and removable hard disk, diskette, CD, DVD, and CD-RW/DVD drives in the appropriate containers or packaging when they are not being used.

Cleaning the cover of your computer

Occasionally clean your computer as follows:

- Prepare a mixture of a gentle kitchen-use detergent (one that does not contain abrasive powder or strong chemicals such as acid or alkaline). Use 5 parts water to 1 part detergent.
- 2. Absorb the diluted detergent into a sponge.
- 3. Squeeze excess liquid from the sponge.
- 4. Wipe the cover with the sponge, using a circular motion and taking care not to let any excess liquid drip.
- 5. Wipe the surface to remove the detergent.
- 6. Rinse the sponge with clean running water.
- 7. Wipe the cover with the clean sponge.
- 8. Wipe the surface again with a dry, soft lint-free cloth.
- **9**. Wait for the surface to dry completely and remove any fibers from the cloth.

Cleaning your computer keyboard

- 1. Absorb some isopropyl rubbing alcohol on a soft, dust-free cloth.
- 2. Wipe the keytop surface with the cloth, ensuring no liquid drips on or between the keys.
- 3. Allow to dry.
- 4. You can use compressed air to remove any crumbs and dust from beneath the keys.

Note: Avoid spraying cleaner directly on the display or the keyboard.

Cleaning your computer display

1. Gently wipe the display with a dry, soft lint-free cloth. If you see a scratchlike mark on your display, it might be a stain transferred from the keyboard or the TrackPoint pointing stick when the cover was pressed from the outside.

- 2. Wipe or dust the stain gently with a soft, dry cloth.
- **3**. If the stain remains, moisten a soft, lint-free cloth with water or a 50-50 mixture of isopropyl alcohol and water that does not contain impurities.
- 4. Wring out as much of the liquid as you can.
- 5. Wipe the display again; do not let any liquid drip into the computer.
- 6. Be sure to dry the display before closing it.

Diagnosing problems

If you have a problem with your computer, you can test it by using PC-Doctor for Windows. To run PC-Doctor for Windows, do as follows:

- 1. Click Start.
- 2. Move the pointer to All Programs (in Windows other than Windows XP, Programs) and then to PC-Doctor [®] for Windows.
- 3. Click PC-Doctor.
- 4. Choose one of the tests, from either Device Categories or Test Scripts.

- Attention

Running any tests may take up to several minutes or longer. Make sure you have time to run the entire test; do not interrupt the test while it is running.

The **System Test** of the **Test Scripts** runs some tests of critical hardware components, but it does not run all of the diagnostic tests in PC-Doctor for Windows. If PC-Doctor for Windows reports that all of the tests in the **System Test** have been run and that it has found no problems, consider running more of the tests in PC-Doctor for Windows.

If you are preparing to contact IBM for support, be sure to print the test log so that you can rapidly provide information to the help technician.

Troubleshooting

If you do not find your problem here, refer to your on-board help system, Access IBM. To open Access IBM, press the Access IBM button. The following section only describes problems that might prevent you from accessing the help system.

Error messages

Message	Solution
0175: Bad CRC1, stop POST task	The EEPROM checksum is not correct (block #6). Have the computer serviced.

To clear the error, enter the IBM BIOS Setup Utility, press F9 to set values to default, then press F10 to save changes. If this does not solve the problem, have the computer serviced.

Errors without messages

Problem:

When I turn on the machine, nothing appears on the screen and the machine does not beep while starting up.

Note: If you are not sure whether you heard any beeps, turn off the computer; then turn it on again, and listen again. If you are using an external monitor, refer to "Computer screen problems" on page 24

Solution:

If a power-on password is set, press any key to display the power-on password prompt, and then type the correct password and press Enter.

If the power-on password prompt does not appear, the brightness level might be set to minimum brightness. Adjust the brightness level by pressing the Fn+Home.

If the screen still remains blank, make sure that:

- The battery is installed correctly.
- The ac adapter is connected to the computer and the power cord is plugged into a working electrical outlet.
- The computer power is on. (Turn on the power switch again for confirmation.)

If these items are properly set, and the screen remains blank, have the computer serviced.

Problem:

When I turn on the machine, nothing appears on the screen, but I hear two or more beeps.

Solution:

Make sure that the memory card is installed correctly. If it is, but the screen is still blank, and you hear five beeps, have the computer serviced.

If you hear 4 cycles of 4 beeps each, the Security Chip has a problem. Have the computer serviced.

Problem:

When I turn on the machine, only a white pointer appears on a blank screen.

Solution:

Reinstall your operating system, and turn on the computer. If you still see only the pointer on the screen, have the computer serviced.

Problem:

My screen goes blank while the computer is on.

Solution

Your screen saver or power management may be enabled. Move the TrackPoint or press a key to exit the screen saver, or press the power switch to resume from standby or hibernation.

Problem:

The DOS full-screen looks smaller.

Solution:

If you use a DOS application that supports only 640×480 resolution (VGA mode), the screen image might look slightly distorted or appear smaller than the display size. This is to maintain compatibility with other DOS applications. To expand the screen image to the same size as the actual screen, start the ThinkPad Configuration Program and click **LCD**; then select the **Screen expansion** function. (The image might still look slightly distorted.)

Note: If your computer has a screen expansion function, you can use the Fn+F8 keys to expand the screen image.

A password problem

Problem:

I forgot my password.

Solution:

If you forgot your power-on password, you must take your computer to an IBM authorized servicer or marketing representative to have the password canceled.

If you forgot your hard disk password, IBM will not reset your password or recover data from the hard disk. You must take your computer to an IBM authorized servicer or an IBM marketing representative to have the hard disk drive replaced. Proof of purchase is required, and a fee will be charged for parts and service.

If you forgot your supervisor password, IBM will not reset your password. You must take your computer to an IBM authorized servicer or IBM marketing representative to have the system board replaced. Proof of purchase is required, and a fee will be charged for parts and service.

A power switch problem

Problem:

The system does not respond, and you cannot turn off the computer.

Solution:

Turn off the computer by pressing and holding the power switch for 4 seconds or more. If the computer is still not reset, remove the ac adapter and the battery.

Keyboard problems

Problem:

All or some of the keys on the keyboard do not work.

Solution:

If the problem occurred immediately after the computer returned from standby mode under Windows NT, enter the power-on password if one has been set.

If an external PS/2 keyboard is connected, the numeric keypad on your computer does not work. Use the numeric keypad on the external keyboard.

If an external numeric keypad or a mouse is connected:

- 1. Turn off the computer.
- 2. Remove the external numeric keypad or the mouse.
- 3. Turn on the computer and try using the keyboard again.

If the keyboard problem is resolved, carefully reconnect the external numeric keypad, external keyboard, or mouse, making sure that you have seated the connectors properly.

If keys on the keyboard still do not work, have the computer serviced.

Problem:

A number appears when you type a letter.

Solution

The numeric lock function is on. To disable it, press and hold Shift; then press NumLk.

Problem:

All or some of the keys on the external numeric keypad do not work.

Solution:

Make sure that the external numeric keypad is correctly connected to the computer.

Problem:

All or some keys on the external PS/2 keyboard do not work.

Solution:

If you are using the X4 UltraBase[™] Dock, make sure the keyboard cable is correctly connected to the keyboard/mouse connector of the X4 UltraBase Dock. If you are using a mouse and keyboard with the X4 UltraBase Dock, you need the keyboard/mouse cable. Make sure that the keyboard/mouse cable is correctly connected to the keyboard/mouse connector of the X4 UltraBase Dock, and that the keyboard cable is correctly connected to the keyboard cable.

If the connection is correct, disconnect the cable and make sure that the built-in keyboard operates properly. If the built-in keyboard works, there is a problem with the external keyboard. Try using a different external keyboard.

TrackPoint problems

Problem:

The pointer drifts when the computer is turned on or after it resumes normal operation.

Solution:

The pointer might drift when you are not using the TrackPoint during normal operation. This is a normal characteristic of the TrackPoint and is not a defect. The pointer drifts for several seconds under the following conditions:

- When the computer is turned on.
- When the computer resumes normal operation.
- When the TrackPoint is pressed for a long time.
- When the temperature changes.

Problem:

The mouse or the pointing device does not work.

Solution:

Make sure that the TrackPoint is set to Automatic in the ThinkPad Configuration Program. Then detach the mouse or the pointing device, and try using the TrackPoint. If the TrackPoint works, the error might be due to the mouse or the pointing device.

Make sure that the cable for the mouse or the pointing device is securely connected to the X4 UltraBase Dock.

If your mouse is incompatible with the IBM PS/2 mouse, disable the TrackPoint, using the ThinkPad Configuration Program.

Note: For more information, see the manual supplied with the mouse.

Problem

The mouse buttons do not work.

Solution

Change the mouse driver to **Standard PS/2[®] Port Mouse**, and then reinstall **IBM PS/2 TrackPoint**. Drivers are provided in the C:\IBMTOOLS\DRIVERS directory on your hard disk drive. If your hard disk drive does not contain device drivers, refer to the ThinkPad Web site. To access this Web site, press the Access IBM button. The Access IBM panel opens. On it, click **Get Help & Support**, and then click **Download & update**. Select **Newest device drivers**.

Problem

The scrolling or magnifying glass function does not work.

Solution

Check the mouse driver in the Device Manager window, and make sure that the IBM PS/2 TrackPoint driver is installed.

Standby and hibernation problems

Problem:

The computer enters standby mode unexpectedly.

Solution:

If the processor overheats, the computer automatically enters standby mode to allow the computer to cool and to protect the processor and other internal components. Also, check the settings for standby mode, using Battery MaxiMiser.

Problem:

The computer enters standby mode immediately after Power-on self-test (POST) (the standby indicator light turns on).

Solution:

Make sure that:

• The battery is charged.

• The operating temperature is within the acceptable range. Refer to "Specifications" on page 5.

If these items are correct, have the computer serviced.

Problem:

The critical low-battery error message is displayed, and the computer immediately turns off.

Solution:

The battery power is getting low. Connect the ac adapter to the computer, or replace the battery with a fully charged one.

Problem:

When you take action to return from standby mode, the computer display remains blank.

Solution:

Check whether an external monitor was disconnected while the computer was in standby mode. Do not disconnect the external monitor while the computer is in standby mode or hibernation mode. If no external monitor is attached when the computer resumes, the computer display remains blank and output is not displayed. This restriction does not depend on the resolution value. Press Fn+F7 to bring up the computer display.

Note: If you use the Fn+F7 key combination to apply a persentation scheme, press Fn+F7 at least three times in three seconds, and the image is displayed on the computer screen.

Problem:

The computer does not return from standby mode, or the standby indicator stays on and the computer does not work.

Solution:

If the system does not return from standby mode, it may have entered standby or hibernation mode automatically because the battery is depleted. Check the standby indicator.

- If the standby indicator is on, your computer is in standby mode. Connect the ac adapter to the computer; then press Fn.
- If the standby indicator is off, your computer is in hibernation mode or power-off state. Connect the ac adapter to the computer; then press power button to resume operation.

If the system still does not return from standby mode, your system may stop responding and you cannot turn off the computer. In this case, you need to reset the computer. If you have not saved your data, it may be lost. To reset the computer, press and hold the power button for 4 seconds or more. If the system is still not reset, remove the ac adapter and the battery.

Problem:

Your computer does not enter standby or hibernation mode.

Solution:

Check whether any option has been selected that would disable your computer from entering standby or hibernation mode.

Problem:

The computer does not enter standby mode as set by the timer under Windows NT.

Solution:

For Windows NT:

If you have enabled the CD-ROM AutoRun feature, the computer does not enter standby mode through the timer. To enable the timer , edit the configuration information in the registry as follows:

```
HKEY_LOCAL_MACHINE\SYSTEM\
CurrentControlSet\Services\Cdrom\
Autorun: 0x1 > Autorun: 0
```

Note: Before you make any changes, back up the computer registry and configuration. If something goes wrong, you can restore the system registry and configuration files.

Problem:

The Fn+F12 key combination does not cause the computer to enter hibernation mode.

Solution:

The computer cannot enter hibernation mode:

- If you are using one of the IBM communication PC Cards. To enter hibernation mode, stop the communication program, and then remove the PC Card or disable the PC Card slot. Click the **Safely Remove Hardware** icon in the taskbar (for Windows XP) or the **Unplug or Eject Hardware** icon in the taskbar (for Windows 2000).
- If the hibernation utility is not installed in Windows NT. To install the hibernation utility, refer to "Installing device drivers" in the Access IBM, your on-board help system.
- If the hibernation mode is not enabled. To enable it, do as follows:

For Windows NT:

- **Note:** You must format your hard disk with the FAT format system to use hibernation mode in Windows NT. If you format your hard disk with NTFS, the default format in Windows NT, you cannot use hibernation mode.
- 1. Start the ThinkPad Configuration Program.
- 2. Click Power Management.

- 3. Click Suspend/Resume Options.
- 4. Click Enable Hibernation.
- 5. Click OK.

For Windows XP or Windows 2000 :

- 1. Start the ThinkPad Configuration Program.
- 2. Click Power Management.
- 3. Click the Hibernate tab.
- 4. Select the hibernate support checkbox.
- 5. Click OK.

Note: You can enter hibernation mode by pressing Fn+F12 only if the PM driver for Windows 2000 or Windows XP has been installed.

Problem:

Under Windows XP, the Fn+F3 key combination does not make the computer screen go blank.

Solution:

Windows XP enables multiple users to log on to the system at the same time. If you are the first user to have logged on to your computer, you can use the Fn+F3 key combination. Otherwise the combination will not work on your computer.

Computer screen problems

Problem:

The screen is blank.

Solution:

- Press Fn+F7 to bring up the image.
 - **Note:** If you use the Fn+F7 key combination to apply a presentation scheme, press Fn+F7 at least three times in three seconds, and the image is displayed on the computer screen.
- If you are using the AC adapter, or using the battery, and the battery status indicator is on (is green), press Fn+Home to make the screen brighter.
- If the standby status indicator is on (is green), press Fn to resume from the standby mode.
- If you still have the problem persists, do the Solution in the problem below.

Problem:

The screen is unreadable or distorted.

Solution:

Make sure that:

- The display device driver is installed correctly.
- The screen resolution and color quality are correctly set.
- The monitor type is correct.

To check these settings, do as follows:

For Windows XP and Windows 2000:

- 1. Right-click on the desktop, click **Properties**, then click the **Settings** tab.
- 2. Check whether the screen resolution and color quality are correctly set.
- 3. Click Advanced.
- 4. Click the Adapter tab.
- 5. Make sure "Intel(R) 82852/82855 GM/GME Graphics Controller" is shown in the adapter information window.
- 6. Click the **Properties** button. Check the "Device status" box and make sure the device is working properly. If not, click the **Troubleshooter** button.
- 7. Click the **Monitor** tab.
- 8. Make sure the information is correct.
- 9. Click the **Properties** button. Check the "Device status" box and make sure the device is working properly. If not, click the **Troubleshooter** button.

Problem:

Incorrect characters appear on the screen.

Solution:

Did you install the operating system or application program correctly? If they are installed and configured correctly, have the computer serviced.

Problem:

The screen stays on even after you turn off your computer.

Solution:

Press and hold the power switch for 4 seconds or more to turn off your computer; then turn it on again.

Problem:

Missing, discolored, or bright dots appear on the screen every time you turn on your computer.

Solution:

This is an intrinsic characteristic of the TFT technology. Your computer's display contains multiple thin-film transistors (TFTs). A small number of missing, discolored, or bright dots on the screen might exist all the time.

Battery problems

Problem:

The battery cannot be fully charged by the power-off method in the standard charge time for your computer.

Solution:

The battery might be over-discharged. Do the following:

- 1. Turn off the computer.
- 2. Make sure that the over-discharged battery is in the computer.
- 3. Connect the ac adapter to the computer and let it charge.

If the battery cannot be fully charged in 24 hours, use a new battery.

If the optional Quick Charger is available, use it to charge the over-discharged battery.

Problem:

Your computer shuts down before the battery status indicator shows empty, *-or-* Your computer operates after the battery status indicator shows empty.

Solution:

Discharge and recharge the battery.

Problem:

The operating time for a fully charged battery is short.

Solution:

Discharge and recharge the battery. If your battery's operating time is still short, use a new battery.

Problem:

The computer does not operate with a fully charged battery.

Solution:

The surge protector in the battery might be active. Turn off the computer for one minute to reset the protector; then turn on the computer again.

Problem

The battery does not charge.

Solution

You cannot charge the battery when it is too hot. If the battery feels hot, remove it from the computer and allow it to cool to room temperature. After it cools, reinstall it and recharge the battery. If it still cannot be charged, have it serviced.

Hard disk drive problems

Problem:

The hard disk drive makes a rattling noise intermittently.

Solution:

The rattling noise might be heard when:

- The hard disk drive starts accessing the data or when it stops.
- You are carrying the hard disk drive.

• You are carrying your computer.

This is a normal characteristic of a hard disk drive and is not a defect.

Problem:

The hard disk drive does not work.

Solution:

In the startup menu in BIOS Setup Utility, make sure that the hard disk drive is in the "Boot priority order". If it is in the device list of "Excluded from boot order", the hard disk drive is disabled. Move it into the "Boot priority order".

A startup problem

Problem:

The Microsoft[®] Windows[®] operating system will not start.

Solution:

Use the IBM Rescue and Recovery workspace to help solve or identify your problem.

To open IBM Rescue and Recovery, do the following:

- 1. Turn off your PC, and then turn it back on again.
- 2. Watch the screen carefully while your PC starts. When the following prompt is displayed, press the blue Access IBM button to open the Rescue and Recovery workspace: "To interrupt normal startup, press the blue Access IBM button." A window such as this will appear:

In the top panel of the Rescue and Recovery workspace, you can click the following to open other pages or exit the utility:

Events Log The Event Log Viewer enables you to view a log that contains information about events, or tasks, associated with Rescue and RecoveryTM operations.

System Information The System Information Viewer enables you to see key hardware and software information about your computer. This information might be valuable when trying to diagnose problems.

Warranty Status The Warranty Status enables you to see when your warranty expires, the terms of service for your computer, or a list of replacement parts.

Help Provides information about the various pages in the Rescue and Recovery workspace.

Exit Closes the Rescue and Recovery workspace, and resumes the startup sequence that was interrupted.

Other problems

Problem:

The computer locks or does not accept any input.

Solution:

Your computer might lock when it enters standby mode during a communication operation. Disable the standby timer when you are working on the network.

To turn off the computer, press and hold the power switch for 4 seconds or more.

Problem:

The computer does not turn off with the power switch.

Solution:

If the standby indicator is on and you are working under battery power, replace the battery with a fully charged one or change your power source to ac power.

If you still have a problem, press and hold the power switch for 4 seconds or more; this forces the computer to turn off.

Problem:

The computer does not start from a device you want, such as a diskette drive.

Solution:

Refer to the Startup menu of the IBM BIOS Setup Utility. Make sure that the startup sequence in the IBM BIOS Setup Utility is set so that the computer starts from the device you want.

Also make sure that the device from which the computer starts is enabled by checking that there is no ! mark preceding the device name.

Problem:

The computer does not respond.

Solution:

IRQs for the PCI are all set as 11. The computer does not respond because it cannot share the IRQ with other devices. Refer to the ThinkPad Configuration Program.

Problem:

Windows NT does not start; however, the message saying that Windows NT is loading remains on the screen.

Solution:

The USB setting might have been changed to Enabled. If so, it might cause a conflict in allocating memory resources during startup. Disable the setting, using the BIOS Setup Utility.

- 1. Turn your computer off and then on again; then, while the message, "To interrupt normal startup, press the blue Access IBM button" is displayed at the lower left of the screen, press the F1 key to start IBM BIOS Setup Utility.
- 2. The IBM BIOS Setup Utility menu appears.
- 3. With the cursor key, select Config; then press Enter.
- 4. Select USB by pressing Enter.
- 5. With the F5 or F6 key, select **Disable**; then press Enter.
- 6. Press F10 and Enter to save this setting and exit this utility.

Problem:

The computer can not play a CD, or the sound quality is not good.

Solution:

that it will play, or that, if it does play, the sound quality will be good.



Problem:

Playback of DVD is not smooth in Windows 2000.

Solution:

If you select the Maximum Battery mode for the Intel SpeedStepTM technology, this problem may occur. This mode is designed to achieve maximum battery life by switching the processor speed between the regular low speed and half of that speed, depending on how much the processor is used. If the use increases, Intel SpeedStep switches the processor speed to the lower speed. Operation in this mode can severely degrade the performance of the processor, and thus cause the playback of a DVD to be jerky.

To avoid or reduce this problem, you can choose any of three other modes of operation, as follows:

- Maximum Performance: Keeps the processor speed high at all times.
- Automatic: Switches the processor speed between high and low, depending on how much the processor is used. If the use increases, Intel SpeedStep switches the processor speed to high.
- **Battery Optimized Performance:** Keeps the processor speed low at all times.

To choose a mode, do the following:

- 1. Start the ThinkPad Configuration Program.
- 2. Click Power Management.
- 3. Click the Intel SpeedStep technology tab.
- 4. From the list, select the mode you want.
- 5. Click OK.

Problem:

If your operating system is Windows 2000 and you are using a USB 1.x device, then when your computer returns from standby or hibernation mode to normal operation, the "Unsafe Removal of Device" message may appear.

Solution:

You can safely close this message. It is displayed because of the USB 2.0 driver problem on Windows 2000. You can get detailed information in the More Information section of the Microsoft Knowledge Base 328580 and 323754. Visit the Microsoft Knowledge Base homepage at http://support.microsoft.com/, type the number of the knowledge base article you need in the search field, and click the Search button.

Starting IBM BIOS Setup Utility

Your computer provides a program, called IBM BIOS Setup Utility, that enables you to select various setup parameters.

- Config: Set the configuration of your computer.
- Date/Time: Set the date and time.
- Security: Set security features.
- Startup: Set the startup device.
- Restart: Restart the system.

Note: You can set many of these parameters more easily by using the ThinkPad Configuration Program.

To start IBM BIOS Setup Utility, do as follows:

- 1. To protect yourself against accidental loss of data, back up your data and computer registry. For details, refer to "Back up and restore tools" in Access IBM.
- 2. Remove any diskette from the diskette drive, and then turn off the computer.
- **3**. Turn on the computer; then, while the "To interrupt normal startup, press the blue Access IBM button" message is displayed at the lower-left of the screen, press the Access IBM button.
- 4. IBM Rescue and Recovery workspace opens, and click **Access BIOS**. The System Restart Required window is displayed, click **Yes**. The computer restarts, and IBM BIOS Setup Utility screen appears.

If you have set a supervisor password, the IBM BIOS Setup Utility menu appears after you enter the password. You can start the utility by pressing Enter instead of entering the supervisor password; however, you cannot change the parameters that are protected by the supervisor password. For more information, refer to the on-board help.

- 5. Using the cursor keys, move to an item you want to change. When the item you want is highlighted, press Enter. A submenu is displayed.
- 6. Change the items you wish to change. To change the value of an item, use the F5 or F6 key. If the item has a submenu, you can display it by pressing Enter.
- 7. Press F3 or Esc to exit from the submenu. If you are in a nested submenu, press Esc repeatedly until you reach the IBM BIOS Setup Utility menu.

Note:If you need to restore the settings to their original state as of the time of purchase, press F9 key to load the default settings. You can also select an option in the Restart submenu to load the default settings or discard the changes.

8. Select Restart; then press Enter. Move the cursor to the option you want for restarting your computer; then press Enter. Your computer restarts.

Recovering pre-installed software

Your computer hard disk has a hidden, protected area for backups. Contained within this area is a complete backup of the hard disk as it was shipped from the factory and a program called the IBM Rescue and Recovery.

If you installed the IBM Rapid Restore Ultra program, the IBM Rescue and Recovery also contains additional IBM Rapid Restore Ultra backups that reflect the contents of the hard disk, as it existed at various points in time.

You can use the Rescue and Recovery workspace to restore the contents of the hard disk to an earlier state using any of the backup images stored in the protected area. Rescue and Recovery workspace runs independently of the Windows operating system. Therefore, you can start it by pressing the blue Access IBM button when prompted during startup.

After the Rescue and Recovery workspace opens you can perform a recovery operation, even if you are unable to start Windows. For more information about the IBM Rapid Restore Ultra program, see Backing up and restoring data. For more information about the IBM Rescue and Recovery, see Interrupting the normal startup sequence.

To recover the hard disk to its original contents, do the following:

Note: The recovery process might take up to 2 hours.

Attention: All of the files on the primary hard disk partition (usually drive C) will be lost in the recovery process. If possible, be sure to back up copies of the files you have saved on your drive C before you begin.

Note: You might need to use a diskette drive in the recovery process. Use a drive that is compatible with your ThinkPad computer.

- 1. If possible, save all your files and shut down your operating system.
- 2. Turn off your computer.
- **3**. Turn on your computer. Watch the display carefully. When the following message is displayed, press the blue Access IBM button to open the IBM Rescue and Recovery: "To interrupt normal startup, press the blue Access IBM button." The Rescue and Recovery workspace opens.
- 4. Click Restore to factory contents.
- 5. Follow the instructions on the screen.
- 6. When the recovery process finishes, press Enter key. Your computer will restart with the pre-installed operating system, drivers, and software.

Upgrading the hard disk drive

You can increase the storage capacity of your computer by replacing the hard disk drive with one of greater capacity. You can purchase a new hard disk drive from your IBM reseller or IBM marketing representative.

Note: Replace the hard disk drive only if you upgrade it or have it repaired. The connectors and bay of the hard disk drive were not designed for frequent changes, or drive swapping. The IBM Rescue and Recovery workspace and the Product Recovery program is not contained in the optional hard disk drive.


Handling a hard disk drive

- Do not drop the drive or subject it to physical shocks. Put the drive on a material, such as soft cloth, that absorbs the physical shock.
- Do not apply pressure to the cover of the drive.
- Do not touch the connector.

The drive is very sensitive. Incorrect handling can cause damage and permanent loss of data on the hard disk. Before removing the hard disk drive, make a backup copy of all the information on the hard disk, and then turn the computer off. Never remove the drive while the system is operating, in standby mode, or in hibernation mode.

To replace the hard disk drive, do the following.


- 1. **Turn off the computer**; then disconnect the ac adapter and all cables from the computer.

- 3. Remove the battery.
- 4. Remove the screw that secures the hard disk drive.










- **9**. Close the computer display and turn the computer over so that its bottom side is up.
- 10. Reinstall the screw.


- 11. Reinstall the battery.

Replacing the battery


- 1. **Turn off the computer, or enter hibernation mode.** Then disconnect the ac adapter and all cables from the computer.

4. Slide and hold the battery latch **1** ; then remove the battery **2** .




5. Align the front of a fully charged spare battery with the front side of the battery space in the computer; then gently push the battery into the space.

Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract.

What this Warranty Covers

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications") which are available on request. The warranty period for the Machine starts on the original Date of Installation and is specified in Part 3 -Warranty Information. The date on your invoice or sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part. Unless IBM specifies otherwise, these warranties apply only in the country or region in which you purchased the Machine. THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND **REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR** IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

What this Warranty Does not Cover

This warranty does not cover the following:

- any software programs, whether pre-loaded or shipped with the Machine, or installed subsequently;
- failure resulting from misuse (including but not limited to use of any Machine capacity or capability, other than that authorized by IBM in writing), accident, modification, unsuitable physical or operating environment, or improper maintenance by you;

- failure caused by a product for which IBM is not responsible; and
- any non-IBM products, including those that IBM may procure and provide with or integrate into an IBM Machine at your request.

The warranty is voided by removal or alteration of identification labels on the Machine or its parts.

IBM does not warrant uninterrupted or error-free operation of a Machine. Any technical or other support provided for a Machine under warranty, such as assistance via telephone with "how-to" questions and those regarding Machine set-up and installation, is provided **WITHOUT WARRANTIES OF ANY KIND**.

How to Obtain Warranty Service

If the Machine does not function as warranted during the warranty period, contact IBM or your reseller to obtain warranty service. If you do not register the Machine with IBM, you may be required to present proof of purchase as evidence of your entitlement to warranty service.

What IBM Will Do to Correct Problems

When you call for service, you must follow the problem determination and resolution procedures that IBM specifies. becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item.

Your Additional Responsibilities

Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service.

You also agree to:

- 1. ensure that the Machine is free of any legal obligations or restrictions that prevent its exchange;

Limitation of Liability

IBM is responsible for loss of, or damage to, your Machine only while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller are responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM for any reason. You should remove all such information from the Machine prior to its return.

Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, IBM is liable for no more than

- 1. damages for bodily injury (including death) and damage to real property and tangible personal property; and
- 2. the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code ("LIC").

This limit also applies to IBM's suppliers and your reseller. It is the maximum for which IBM, its suppliers, and your reseller are collectively responsible.

UNDER NO CIRCUMSTANCES IS IBM, ITS SUPPLIERS OR RESELLERS LIABLE FOR ANY OF THE FOLLOWING EVEN IF INFORMED OF THEIR POSSIBILITY: 1) THIRD PARTY CLAIMS AGAINST YOU FOR DAMAGES (OTHER THAN THOSE UNDER THE FIRST ITEM LISTED ABOVE); 2) LOSS OF, OR DAMAGE TO, DATA; 3) SPECIAL, INCIDENTAL, OR INDIRECT DAMAGES OR FOR ANY ECONOMIC CONSEQUENTIAL DAMAGES; OR 4) LOST PROFITS, BUSINESS REVENUE, GOODWILL OR ANTICIPATED SAVINGS. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

Governing Law

Both you and IBM consent to the application of the laws of the country in which you acquired the Machine to govern, interpret, and enforce all of your and IBM's rights, duties, and obligations arising from, or relating in any manner to, the subject matter of this Statement of Limited Warranty, without regard to conflict of law principles.

THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE OR JURISDICTION TO JURISDICTION.

Jurisdiction

All of our rights, duties, and obligations are subject to the courts of the country in which you acquired the Machine.


