# Installation and user's guide

This book contains the information you need to install and use your  $\text{IBM}^{\#}$  10/100 Ethernet Server Adapter.

# System requirements

Before installing the adapter, check your computer for the following configuration requirements:

- One open 32-bit PCI slot
- The latest BIOS for your computer
- Microsoft<sup>®</sup> Windows<sup>®</sup> 2000 Professional, Windows NT<sup>®</sup> 4.0, Windows Millenneum Edition (Me), Windows 98, Windows 95, Novell<sup>®</sup> NetWare 3x to 5x, Linux<sup>®</sup>, Solaris<sup>®</sup>, UnixWare<sup>®</sup>, or DOS<sup>®</sup>.
- · Windows NT requires Service Pack 5 or later.
- For NetWare, update to the latest Support Pack available. The required NLMs on this CD.


# Installing the adapter

1. Turn off your computer and all attached devices, and unplug all cables from your computer and all attached devices.

#### <sup>–</sup> Warning

Turn off and unplug the computer before removing the cover. Failure to do so could endanger you and may damage either the adapter, the computer, or both. For servers with Hot Plug support, see your server documentation.

- 2. Remove the cover bracket from an unused 32-bit slot by unscrewing the screw that secures it. Make sure that the cover bracket does not come into contact with any conducting part of the system board.
- 3. If you want to enable the Wake on Lan (WOL) feature, see "Using Wake on Lan" on page 1-4 before completing the rest of these steps.



- 4. Push the adapter into the slot until the adapter is firmly seated, and then secure the adapter bracket with the screw you removed in step 2.
- 5. Repeat steps 2 through 5 for each adapter you want to install.
- 6. Replace the computer cover and plug in the computer.
- 7. Turn on the computer. The computer BIOS automatically assigns resources to the adapter(s). If you get a PCI configuration error, see "PCI configuration troubleshooting" on page B-2.

# Attaching the network cable

Connect the network cable to the adapter using Category 3, 4, or 5 Twisted Pair Ethernet (TPE) network cable for 10Mbps networks, and Category 5 TPE cable for 100 Mbps residential networks. For maximum cable lengths, see "Appendix C. Adapter specifications" on page C-1.


To configure the adapter, see the instructions for your operating system in "Installing the network drivers" on page 1-5.

### Connecting the Wake on Lan power cable

**Note:** The WOL cable is not necessary for PCI 2.2 compliant systems. However, you can connect the WOL cable on these systems with no adverse effect.

For the WOL feature to work correctly, the adapter must be connected to a continuous power source. This allows the adapter to "listen" to the network even when the computer is turned off. To install the WOL power cable, follow these directions:

- 1. Turn off you computer and all attached devices. Unplug all cords and cables from your computer.
- 2. Remove the computer cover.
- 3. Locate the 3-pin WOL connector on the adapter. Attach one end of the WOL cable to the adapter as shown.



- 4. Attach the other end of the WOL cable to the system board, as shown.
- 5. Some computers might require you to change a setting in your computer BIOS or Setup program to enable the WOL feature. Check the documentation that comes with your computer for more information.

6. Replace the computer cover and plug in the computer.

#### Using Wake on Lan

The Wake on Lan (WOL) feature operates according to a published specification. The specification allows designers to build network adapters that are capable of "listening" to network activity even when the computer is turned off.

WOL adapters had a special low-power standby mode that is active when the rest of the computer is without power. The adapter will respond to a special wake-up packet sent by another computer or network device. Typically, this wake-up packet causes the adapter to signal the computer to turn on and run a pre-defined program.

The wake-up packet structure and behavior are defined in a WOL information brief, available on the Web at http://www.pc.ibm.com/us/infobrf/iblan.html

# Installing the network drivers

This section includes driver installation procedures for the following operating systems:

- Windows 2000 (For Windows 95, Windows 98, and Windows Me, see the online User's Guide)
- Windows NT 4.0 servers/workstations
- Novell NetWare 5.x servers (For 3.x, 4.x, and DOS clients, see the online User's Guide)
- Linux, Solaris, UnixWare 2.x and 7.0 (See the online User's Guide)

You can install drivers directly from the CD or you can also create installation diskettes. To create installation diskettes, see "Making a diskette" on page 1-7.

# Windows 2000

After you install the adapter in the computer, connect the cable, plug in the power cord, and start the computer, Windows displays the **Found New Hardware** dialog box and starts the **Found New Hardware Wizard**. Follow this procedure to install the correct driver.

- 1. Insert the *IBM 10/100 Ethernet Server Adapter Family* CD into the CD-ROM drive. If the CD autorun program starts, close this window at this time.
- 2. In the Wizard Welcome window, click Next.
- 3. Select Search, then click Next.
- 4. In the Locate Driver window, select the CD-ROM box, then click Next.
- 5. Click Next.
- 6. Click Finish.
- 7. Restart your computer.

# Windows NT 4.0 servers

The E100NT4.SYS NDIS 4.0 driver supports Windows NT 4.0 servers and workstations. This driver does not support Windows NT 3.51 or earlier versions of Windows NT.

**Note:** Before installing this driver, review the Service Pack requirements in "System requirements" on page 1-1. If you are also installing Windows NT 4.0 at this time, you must first create a diskette for the driver installation. See "Making a diskette" on page 1-7.

To install the driver, follow these instructions.

- 1. Click Start, then click Settings, and then click Control Panel.
- 2. Click the Network icon.
- 3. Select Adapters, and click Add.

- 4. Select Have Disk.
- 5. Insert the *IBM 10/100 Ethernet Server Adapter Family* CD into your CD-ROM drive.
- 6. Type the path to your CD-ROM drive in the dialog box, and then click OK.
- 7. Follow the instructions on your screen to install the drivers. When the adapter is added, it appears in the Network adapters list.
- 8. Click Ok, and then click Close. When prompted, restart your computer.

# **Novell NetWare 5.x**

**Note:** For other NetWare server and client operating systems, see the online User's Guide on your CD.

Use the NetWare Install program to install the adapter driver (driver name: CE100B.LAN in the /NWSERVER folder). Review the Service pack requirements in "System requirements" on page 1-1.

**Note:** Prior to installing, either load DOS or NetWare drivers for your server CD-ROM driver or create a diskette from the IBM 10/100 Ethernet Adapter Family CD on a different computer. See "Making a diskette" on page 1-7.

To install the driver, follow these instructions.

- 1. From the NetWare console, type NWCONFIG and press Enter.
- 2. Select **Driver options**, and then press Enter.
- 3. Select Configure network drivers, and then press Enter.
- 4. Select Load an additional driver, and then press Enter.
- 5. Insert the *IBM 10/100 Ethernet Server Adapter Family* CD into your CD-ROM drive, or insert the diskette you created into your diskette driver, and select **Install an unlisted driver** by pressing Insert.
- 6. If you are using a diskette, press Enter. If you are using the CD, press F3 and enter the CD-ROM drive as the source path.
- 7. Press Enter to select the driver.
- 8. Select Yes, and then press Enter.
- 9. To modify any driver parameters or protocols, select **Select/Modify driver parameters and protocols**, and then press Enter. The slot number is a required field and must be entered. If you have multiple adapters, enter the slot number for the adapter you are currently configuring. When finished configuring the driver, select **Save parameters and load driver** to continue.

**Note:** If your computer contains a single IBM 10/100 Ethernet Server adapter, you may enter any number for the slot. The driver will automatically detect the correct slot number and load successfully.

If your system contains more than one IBM 10/100 Ethernet Server adapter, use Alt+Esc to switch to the console screen in NetWare to find the valid slot numbers for your adapters. Type LOAD CE100 and press Enter. The driver will attempt to load and prompt you with the available slot numbers. Write down the slot numbers, and then press Esc to abort loading the driver. Press Alt+Esc to switch back to the Install screen and enter the correct slot number.

- 10. To complete the driver installation, go back to the Configuration Options screen by pressing Esc until you see the Configuration Options screen, and then follow the on-screen instructions.
- 11. Choose Exit to return to the server console prompt.
  - **Note:** If you are installing multiple adapters, repeat the driver installation process for each new adapter in the server.
  - **Note:** If the adapter cannot transmit or receive following the installation, you may need to modify the frame type or LOAD and BIND statements in the AUTOEXEC.NCF file.

#### Making a diskette

If you need to use a floppy disk to install the adapter drivers, use the MAKEDISK.BAT utility located in the /MAKEDISK directory on the *IBM 10/100 Ethernet Server Adapters Family* CD. For your convenience, these BAT files are available from the root directory of the *IBM 10/100 Ethernet Server Adapters Family* CD as well:

# Additional setup and configuration

The IBM 10/100 Ethernet Server Adapter family supports a wide range of advanced networking features.

Adapter Teaming: Maximize throughput and fault tolerance in your servers with the following.

- Adapter Fault Tolerance (AFT) provides automatic redundancy for your adapter. If the primary adapter fails, the secondary takes over. AFT supports two to four adapters per team.
- Adaptive Load Balancing (ALB) allows balancing the transmission data flow among two to four adapters. Also includes the AFT option. works with any Ethernet switch.
- Cisco Fast EtherChannel (FEC) creates a team of two, four, six, or eight adapters to increase transmission and reception throughput. also includes AFT option. Requires a switch with FEC capability.

**Virtual LAN**: improve network security and efficiency by creating VLANs for your workgroups.

PROSet: adapter configuration utility.

Management features: configure Wake on LAN and Boot Agent.

Priority Packet: set up priority filters on your network traffic.

# Appendix B. Troubleshooting

The appendix describes corrective actions for a number of common problems.

#### 1. Check the LED lights on the adapter

If the LINK light is not on, check all the connections at the adapter ad link partner. Make sure the link partner is set to 100 Mbps and full duplex, and that the driver is loaded.

#### 2. Make sure the cable is installed properly

The network cable must be securely attached at all connections. If the cable is attached but the problem persists, try a different cable.

#### 3. Test the adapter

From DOS, run the adapter and network tests in DIAG100.EXE, located on the root directory of the *IBM 10/100 Ethernet Server Adapter* CD.

#### 4. Check the Common problems table and try the recommended solutions

Check the following table for solutions to fit your problem.

If none of these steps work, see "Appendix A. Help and service information" on page A-1.

Problem	Solution
Your computer can't find the adapter	<ul> <li>Make sure the adapter is seated firmly in the slot.</li> <li>Try a different PCI busmaster slot. See your server documentation to identify busmaster slots.</li> <li>Try a different IBM 10/100 Ethernet Adapter</li> </ul>
Diagnostics pass but the connection fails	<ul><li>Try running the <i>Sender-Responder diagnostic</i> test.</li><li>Make sure the network cable is securely attached.</li></ul>
An adapter stopped working after you installed the IBM 10/100 Ethernet family adapter	<ul> <li>Make sure the cable is connected to the IBM 10/100 Ethernet Adapter and not another adapter.</li> <li>Check for resource conflict. See "PCI configuration troubleshooting" on page B-2</li> <li>Make sure both adapters are seated firmly in the slot.</li> <li>Check all cables</li> </ul>

Problem	Solution
The adapter stopped working without apparent cause.	<ul> <li>Try reseating the adapter</li> <li>The network driver files may be damaged or deleted. Try reinstalling the drivers.</li> <li>Try a different 10/100 Ethernet adapter</li> <li>Try enabling or disabling the auto-negotiation setting on the link partner (this setting must be set the same on both the switch and the adapter).</li> <li>Note: The adapter LNK LED may light even if communications between the adapter and its link partner have not been properly established. Proper configuration of link partners consists of both sides being set to either auto-negotiate or set with the same speed and duplex settings.</li> </ul>
The LNK LED does not light	<ul> <li>Make sure you loaded the adapter driver.</li> <li>Check all connections at the adapter or switch.</li> <li>Try another port on the buffered repeater or switch.</li> <li>Try enabling or disabling the auto-negotiation setting on the link partner (this setting must be set the same on both the switch and the adapter).</li> </ul>
The Wake on Lan feature is not working	<ul> <li>Make sure the WOL cable is attached and that power is being applied to the computer.</li> <li>Check the BIOS for its WOL setting. Some computers may need to be configured for WOL. See the documentation that comes with your computer.</li> <li>Make sure the network cable is fully attached to the adapter.</li> </ul>

# PCI configuration troubleshooting

Some PCI computers require additional steps to configure a PCI adapter. Try the following if you are having problems configuring the adapter.

- Disable Plug n Play (PnP) in the BIOS. In some computers, you may need to use the BIOS Setup program to disable PnP if resources are not properly assigned to adapters and other add-in cards.
- Enable the PCI slot. In some PCI computers, you may need to use the BIOS Setup program to enable the PCI slot. This is especially common in PCI computers with the PhoenixBIOS.
- Enable the slot for busmaster. You must install the 10/100 Ethernet Server adapter in a busmaster slot. Some BIOS Setup programs require you to enable the slot for busmaster/master. Check your BIOS Setup program and the computer documentation to make sure the slot is set for busmaster/master.

- Configure the slot for level-triggered interrupts. The PCI slot the adapter is using must be configured for level-triggered interrupts instead of edge-triggered interrupts. Check your BIOS Setup program to make sure triggering is set up.
- Reserve interrupts and/or memory addresses for ISA adapters. This prevents PCI cards from trying to use the same settings as ISA cards. Check your BIOS Setup program; there may be IRQ options such as Enable for ISA or Disable for PCI.

Here are some examples of BIOS Setup program parameters:

PCI slot #:	slot where the adapter is installed (1-3)
Master:	ENABLED
Slave:	ENABLED
Latency timer	40 - 80
Interrupt:	Choose any one of several that the BIOS Setup provides
Edge/Level	Level

The exact wording of the parameters varies with different computers.

# IBM Statement of Limited Warranty for United States, Puerto Rico, and Canada (Part 1 - General Terms)

This Statement of Warranty includes Part 1 - General Terms and Part 2 -Country-unique Terms. **The terms of Part 2 may replace or modify those of Part 1**. The warranties provided by IBM in this Statement of Warranty apply only to Machines you purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. Nothing in this Statement of Warranty affects any statutory rights of consumers that cannot be waived or limited by contract. If you have any questions, contact IBM or your reseller.

Machine - IBM 10/100 Ethernet Server Adapters Family Warranty period\* - Lifetime

\* Contact your place of purchase for warranty service information. Some IBM Machines are eligible for on-site warranty service depending on the country where service is performed.

#### The IBM Warranty for Machines

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications. The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your sales receipt is the Date of Installation, unless IBM or your reseller informs you otherwise.

During the warranty period IBM or your reseller, if approved by IBM to provide warranty service, will provide repair and exchange service for the Machine, without charge, under the type of service designated for the Machine and will manage and install engineering changes that apply to the Machine. If a Machine does not function as warranted during the warranty period, and IBM or your reseller are unable to either 1) make it do so or 2) replace it with one that is at least functionally equivalent, you may return it to your place of purchase and your money will be refunded. The replacement may not be new, but will be in good working order.

#### **Extent of Warranty**

The warranty does not cover the repair or exchange of a Machine resulting from misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, or failure caused by a product for which IBM is not responsible. The warranty is voided by removal or alteration of Machine or parts identification labels.


