Product description

The IBM HiFD 200 MB Internal Drive is a 3.5-inch ATAPI (AT Attachment Packet Interface) drive that replaces your existing diskette drive. The HiFD drive is supported in computers that use the industry-standard AT attachment/integrated drive electronics (ATA/IDE) architecture.

The HiFD drive is more versatile than a 1.44 MB¹ or 2.88 MB diskette drive because in addition to reading from and writing to standard 1.44 MB and 720 KB² diskettes, the HiFD drive can read from and write to HiFD 200 MB diskettes. You can conserve space on your hard disk by using your HiFD drive to store and organize large files on HiFD 200 MB diskettes. HiFD 200 MB diskettes can easily hold multimedia, imaging, transaction-processing, or database files. The HiFD drive and HiFD diskettes are supported by Microsoft[®] Windows[®] 98, Windows 95 OSR2 or later, and Microsoft Windows NT[®] Workstation.

Installation requirements

To install the HiFD drive you must have the following items.

Documentation

You will need the documentation that comes with your computer, operating system, or IDE bus adapter if the adapter is separate from the computer.

Hardware

You must have the following hardware.

- IBM computer or compatible computer with an Intel[®] Pentium[®] microprocessor and 16 MB³ RAM (random-access memory)
- 3.5-inch, 1.44 MB diskette drive slot or bay

IDE bus

Your computer must have an IDE port on the system board or on an IDE bus adapter. If the interface cable connectors in your computer have 40 pins, your computer uses the IDE architecture. If you are not sure about your IDE bus adapter, see the documentation that comes with your computer.

IDE cables and connectors

The IDE cables connect the IDE port on the system board, or on an IDE bus adapter, to your IDE storage devices. IDE storage devices are hard disk drives, CD-ROM drives, and tape drives.

If your computer has one IDE port, you can attach a maximum of two devices, as shown in the following illustration.



If your computer has two IDE ports (one IDE cable on each port), you can attach up to four devices (two devices on each cable).

If your IDE cables have only one connector, you can replace one of the cables with the two-connector IDE cable that comes with this option package.

If you are attaching the HiFD drive to the same port as another device, such as a hard disk drive or tape drive, you might need to change the configuration of that device. For more information, refer to the documentation that comes with the device.

Power connector

You will need an unused power connector on a cable coming from the computer power supply in order to provide power to the drive.

HiFD drive mounting

The HiFD drive replaces the 1.44 MB diskette drive. You might need both a flat-blade and a Phillips-head screwdriver for the installation.

Installing the drive

Follow these steps to install the HiFD drive in your computer.

Step 1. Opening the computer

- 1. Be sure to back up your computer files before beginning installation.
- 2. Turn off the computer and all attached devices.
- 3. Unplug the cables from the power outlets for your computer and all attached devices.

It is now safe to open your computer.

For specific information about opening your computer, see the documentation that comes with the computer.

Step 2. Unpacking the drive

Follow these steps when you unpack your drive.

- 1. Do not open the antistatic bag until you are ready to install the drive. Static electricity can damage the drive and other computer components.
- Touch your hand and the inner conductive surface of the antistatic bag containing the drive to an unpainted metal surface on the computer for two seconds. This drains static electricity from the bag and your body.

- 3. Before handling the drive, ground yourself by touching an unpainted surface on the computer. Ground yourself again after leaving and returning to your work area.
- 4. Always handle the drive by its edges. Do not touch any exposed printed circuitry, components, or connector pins.
- 5. While installing the drive, avoid all unnecessary handling. Rough handling can damage the heads, rotating disks, and bearings inside the drive housing.
- 6. If you must put the drive down, place the antistatic bag on a flat padded surface, such as a magazine, and place the drive on the bag with the component side facing up.

Step 3. Removing an existing diskette drive

To remove an existing diskette drive:

- 1. Remove the cables that connect the diskette drive to the computer.
- 2. Remove the existing diskette drive from the drive bay using one of the following procedures:
 - If the diskette drive is attached directly to the drive bay:
 - a. Remove the screws that attach the drive to the bay.
 - b. Remove the drive from the bay.
 - If the diskette drive is attached to the drive bay by a slide mount:
 - a. Slide the drive out of the bay.
 - b. Remove the screws from the slide attachments.
 - c. Remove the slide attachments from the drive.
 - If the diskette drive is attached to the drive bay by an insert bracket:
 - a. Remove the screws attaching the insert bracket to the drive bay.
 - b. Remove the bracket from the bay.
 - c. Remove the screws attaching the drive to the bracket.
 - d. Remove the drive from the bracket.

Step 4. Configuring the drive

This section provides information on configuring the HiFD drive so that you can use it in 1.44 MB diskette mode and in HiFD diskette mode.

Configuring the drive for the 1.44 MB diskette mode

The HiFD drive comes with a jumper placed on position 1, as shown.



This jumper placement configures the drive in 1.44 MB mode so that you can replace an existing diskette drive with the HiFD drive and use the HiFD drive as the A drive. The drive will only work in the supported IBM computer systems when the jumper is on position **1**.

Configuring the drive for the HiFD mode

You must configure the drive as Slave or Master so that it will work in HiFD mode. The jumper setting configurations for your drive are shown in the following diagram. **Note:** The Cable Select and No Connection configurations do not apply to IBM computers.

If you will be connecting the drive to an IDE cable that already has a Master device connected to the cable, be sure that your HiFD is configured as a Slave (factory setting).

If you are installing the drive as the only drive on the IDE cable, configure the drive as a Master.

Step 5. Mounting the drive in the bay

Attention: Be sure to use the mounting screws that come with your drive. You might damage your drive if you use mounting screws that are too long.

To attach the HiFD drive directly to a 3.5-inch drive bay, align the bay screw holes with the drive screw holes; then hand thread the drive screws through the holes.

Step 6. Connecting the drive and the cables

This section provides information on connecting the drive to the IDE cable, the diskette-drive cable, and the diskette-drive power cable.

Connecting the drive to the option package IDE cable

If you will be connecting the drive to an IDE cable already installed in your computer, go to "Connecting the drive to the computer cables" on page 1-8.

If you will be using the included two-drop IDE cable to connect the drive to a tower computer, unwrap the cable and continue with "Connecting the drive to the computer cables" on page 1-8.

If you will be using the included two-drop IDE cable to connect the drive to a desktop computer, review the following diagrams to determine the correct way to wrap the cable in your computer system.

If your system looks like **Desktop Computer A**, connect the included two-drop IDE cable using instructions given in "Connecting the IDE cable in Desktop Computer A" on page 1-7.

If your system looks like **Desktop Computer B**, connect the included two-drop IDE cable using instructions given in "Connecting the IDE cable in Desktop Computer B" on page 1-8.

Connecting the IDE cable in Desktop Computer A



- 1. Connect the middle cable connector to the HiFD drive 2.
- 2. Find the connector at the end of the cable that is closer to the middle cable connector; then connect it to the computer IDE port 1.



- 3. Thread the connector on the other end of the cable through the divider bracket slot and the notches **1** on the system board.
- 4. Secure the cable by closing the clip on the divider bracket **3**.
- 5. Connect the other end cable connector to a CD-ROM drive or another IDE device installed in the computer **2**.
- 6. Go to "Connecting the drive to the computer cables" on page 1-8 for information on connecting the diskette-drive cable and the diskette-drive power cable.

Connecting the IDE cable in Desktop Computer B



- 1. Connect the middle cable connector to a CD-ROM drive or another IDE device already installed in the computer **2**.
- Find the connector on the end of the cable that is closer to the middle cable connector and connect it to the computer IDE port
 .
- 3. Thread the connector on the other end of the cable through the divider bracket on the system board 1; then connect it to the HiFD drive.
- 4. Go to "Connecting the drive to the computer cables" for information on connecting the diskette-drive cable and the diskette-drive power cable.

Connecting the drive to the computer cables



- **Note:** If you have connected the drive to the included two-drop IDE cable, go to step 2 below.
- 1. Connect the drive to the computer IDE cable.

- a. Connect the drive to an available 40-pin connector on the computer IDE cable.
- b. Align the cable so that the color-coded edge is closest to the power-cable connector 3. The cable connector is keyed and fits only one way.
- c. The IDE cable can have up to three connectors. For the best signal quality when you are connecting only one Master device on the IDE cable, connect one end of the cable to the IDE port and connect the device to the connector to the other end of the cable. Do not use the middle connector.
- d. If you are connecting two devices on the IDE cable, connect one end of the cable to the IDE port and connect the Master and Slave devices to the remaining connectors on the other end. If you need a second cable, you can use the IDE cable that comes with the option package. For more information on the option package IDE cable, go to "Connecting the drive to the option package IDE cable" on page 1-6.
- Connect one end of the diskette-drive cable to the diskette drive connector on the HiFD drive, as shown 1, and connect the other end of the diskette-drive cable to the computer diskette drive connector. The cable connector is keyed and fits only one way.
- Connect an available dc diskette-drive power-cable connector to the four-pin dc power connector on the HiFD drive, as shown 2. Be sure that the cables will not be pinched or crowded by the computer cover and that all other cable and power connections are secure.

Step 7. Completing the hardware installation

To complete the installation of the drive:

- 1. Verify that the drive is securely mounted and the cables are firmly attached.
- Verify that the startup hard disk drive is connected as the Master on the primary IDE port. For more information on the computer IDE ports, refer to the documentation that came with your computer.
- 3. Verify that the cables do not interfere with the computer cover and do not block the power-supply fan blades or air-flow paths.
- 4. Reinstall the computer cover.
- 5. Reconnect all devices. Make sure that the keyboard, mouse, and monitor cables are firmly connected.
- 6. Reconnect all ac power cords.

Step 8. Installing the HiFD drive device driver

Note: The label on the HiFD installation CD provides instructions on installing the HiFD drive device driver. If you have any problems with the instructions on the CD label, return to the installation instructions in this section.

Installing the HiFD drive device driver for Windows 98 or Windows 95 OSR2 or later

To install the HiFD drive device driver for Windows 98 or Windows 95 OSR2 or later:

- 1. Turn on your computer and start your operating system.
- 2. Insert the HiFD device driver CD into the computer CD-ROM drive.

If the installation program starts automatically, follow the on-screen instructions; then go to "Using the HiFD drive" on page 1-11 when installation completes.

If the installation program does not start automatically, continue with the next step.

- 3. Click Start.
- 4. Select Settings.
- 5. Click Control Panel.
- 6. Double-click Add New Hardware.
- 7. Click Next twice.
- 8. Place a check in the No I want to select the hardware from a list check box.
- 9. Click Next.
- 10. In the displayed list, select Floppy disk controllers.
- 11. Click Next.
- 12. Click Have Disk
- 13. Type *x*:\disk1\driver\win95 where *x* is the drive letter for your CD-ROM drive.
- 14. Click OK.
- 15. Restart your computer.

Installing the HiFD drive device driver for Windows NT

To install the HiFD drive device driver for Windows NT:

- 1. Turn on your computer and start your operating system.
- 2. Insert the HiFD device driver CD into the computer CD-ROM drive.

If the installation program starts automatically, follow the on-screen instructions; then go to "Using the HiFD drive" on page 1-11 when installation completes.

If the installation program does not start automatically, continue with the next step.

- 3. Click Start.
- 4. Select Settings.
- 5. Click Control Panel.
- 6. Double-click SCSI Adapters.

- 7. Click Drivers.
- 8. Click Add.
- 9. Click Have Disk
- 10. Type *x*:\disk1\driver\winnt4 where *x* is the drive letter for your CD-ROM drive.
- 11. Click OK.
- 12. Restart your computer.

Step 9. Installing the HiFD drive utility software

To install the HiFD drive utility software:

- 1. Turn on your computer and operating system.
- 2. Insert the HiFD device driver CD into the computer CD-ROM drive.
- 3. Click Run.
- 4. Type *x*:\disk1\setup.exe where *x* is the drive letter for your CD-ROM drive.
- 5. Follow the on-screen instructions.

Using the HiFD drive

You can use your HiFD drive in place of your computer diskette drive. Depending on the configured mode, your HiFD drive will be drive A for 1.44 MB or 720 KB diskettes or the next available drive letter (such as D or E) for HiFD 200 MB diskettes.

You can use the HiFD drive and diskettes to:

- Read from and write to 1.44 MB or 720 KB diskettes.
- Conserve hard disk drive space by storing up to 200 MB of data on a HiFD diskette.
- Transport large amounts of information on HiFD diskettes.
- Back up and archive files.
- Store multimedia files that require large amounts of storage space.

Using the HiFD utility software

The HiFD utility software includes the following features:

• HiFD icon

The HiFD icon displays in My Computer after you install the utility software.

HiFD Eject

You can eject a diskette from the HiFD drive by using the right-click button to click the **HiFD** icon and selecting **EJECT** in the pull-down menu. For information on using the emergency diskette eject procedure, refer to "Ejecting a diskette from a HiFD drive" on page 1-12.

HiFD Copy

You can copy files on a HiFD to the HiFD drive by using the right-click button to click the **HiFD** icon and selecting **Copy Disk** in the pull-down menu.

• HiFD Format

Note: You cannot use the Windows **Format** command to format the HiFD drive or HiFD diskettes.

You can format the HiFD drive or a HiFD diskette by using the right-click button to click the **HiFD** icon and selecting **Format** in the pull-down menu.

Write-protecting HiFD diskettes

HiFD diskettes have a sensing hole so that they can be recognized by HiFD drives. A small insertion-protection indentation prevents you from inserting a HiFD diskette into a non-HiFD diskette drive. You can write-protect a HiFD diskette by pushing up the Write-Protect tab on the diskette.

Ejecting a diskette from a HiFD drive

Attention: You might damage the HiFD drive if you press the Eject button too hard.

If a diskette cannot be ejected with the Eject button, you can use the following emergency eject instructions:

- 1. Turn off the computer and all attached devices.
- 2. Unplug the cables from the power outlets for your computer and all attached devices.
- 3. Remove the system faceplate or cover.
- 4. Straighten a large paper clip to form a tool. The straightened end must extend at least 45 mm (1.8 in.).

5. Insert the extended end into the manual-eject hole on the front of the drive, as shown.



- 6. Push the paper clip until the diskette is ejected.
- 7. Gently remove the diskette.

 - a. Remove the screws attaching the insert bracket to the drive bay.
 - b. Remove the bracket from the bay.
 - c. Remove the screws attaching the drive to the bracket.
 - d. Remove the drive from the bracket.

Step 4. Configuring the drive

This section provides information on configuring the HiFD drive so that you can use it in 1.44 MB diskette mode and in HiFD diskette mode.

Configuring the drive for the 1.44 MB diskette mode

The HiFD drive comes with a jumper placed on position 1, as shown.



This jumper placement configures the drive in 1.44 MB mode so that you can replace an existing diskette drive with the HiFD drive and use the HiFD drive as the A drive. The drive will only work in the supported IBM computer systems when the jumper is on position **1**.

Configuring the drive for the HiFD mode

You must configure the drive as Slave or Master so that it will work in HiFD mode. The jumper setting configurations for your drive are shown in the following diagram. **Note:** The Cable Select and No Connection configurations do not apply to IBM

computers.



If you will be connecting the drive to an IDE cable that already has a Master device connected to the cable, be sure that your HiFD is configured as a Slave (factory setting).

If you are installing the drive as the only drive on the IDE cable, configure the drive as a Master.

Step 5. Mounting the drive in the bay

Attention: Be sure to use the mounting screws that come with your drive. You might damage your drive if you use mounting screws that are too long.

To attach the HiFD drive directly to a 3.5-inch drive bay, align the bay screw holes with the drive screw holes; then hand thread the drive screws through the holes.

Step 6. Connecting the drive and the cables

This section provides information on connecting the drive to the IDE cable, the diskette-drive cable, and the diskette-drive power cable.

Connecting the drive to the option package IDE cable

If you will be connecting the drive to an IDE cable already installed in your computer, go to "Connecting the drive to the computer cables" on page 1-21.

If you will be using the included two-drop IDE cable to connect the drive to a tower computer, unwrap the cable and continue with "Connecting the drive to the computer cables" on page 1-21.

If you will be using the included two-drop IDE cable to connect the drive to a desktop computer, review the following diagrams to determine the correct way to wrap the cable in your computer system.

If your system looks like **Desktop Computer A**, connect the included two-drop IDE cable using instructions given in "Connecting the IDE cable in Desktop Computer A" on page 1-20.

If your system looks like **Desktop Computer B**, connect the included two-drop IDE cable using instructions given in "Connecting the IDE cable in Desktop Computer B" on page 1-21.

- 1. Connect the middle cable connector to the HiFD drive **2**.
- 2. Find the connector at the end of the cable that is closer to the middle cable connector; then connect it to the computer IDE port **1**.

- 4. Secure the cable by closing the clip on the divider bracket **3**.

- 3. Thread the connector on the other end of the cable through the divider bracket on the system board 1; then connect it to the HiFD drive.
- 4. Go to "Connecting the drive to the computer cables" for information on connecting the diskette-drive cable and the diskette-drive power cable.

- **Note:** If you have connected the drive to the included two-drop IDE cable, go to step 2 below.
- 1. Connect the drive to the computer IDE cable.

- a. Connect the drive to an available 40-pin connector on the computer IDE cable.
- b. Align the cable so that the color-coded edge is closest to the power-cable connector 3. The cable connector is keyed and fits only one way.
- c. The IDE cable can have up to three connectors. For the best signal quality when you are connecting only one Master device on the IDE cable, connect one end of the cable to the IDE port and connect the device to the connector to the other end of the cable. Do not use the middle connector.
- d. If you are connecting two devices on the IDE cable, connect one end of the cable to the IDE port and connect the Master and Slave devices to the remaining connectors on the other end. If you need a second cable, you can use the IDE cable that comes with the option package. For more information on the option package IDE cable, go to "Connecting the drive to the option package IDE cable" on page 1-19.
- Connect one end of the diskette-drive cable to the diskette drive connector on the HiFD drive, as shown 1, and connect the other end of the diskette-drive cable to the computer diskette drive connector. The cable connector is keyed and fits only one way.
- Connect an available dc diskette-drive power-cable connector to the four-pin dc power connector on the HiFD drive, as shown 2. Be sure that the cables will not be pinched or crowded by the computer cover and that all other cable and power connections are secure.

Step 7. Completing the hardware installation

To complete the installation of the drive:

- 1. Verify that the drive is securely mounted and the cables are firmly attached.
- 2. Verify that the startup hard disk drive is connected as the Master on the primary IDE port. For more information on the computer IDE ports, refer to the documentation that came with your computer.
- 3. Verify that the cables do not interfere with the computer cover and do not block the power-supply fan blades or air-flow paths.
- 4. Reinstall the computer cover.
- 5. Reconnect all devices. Make sure that the keyboard, mouse, and monitor cables are firmly connected.
- 6. Reconnect all ac power cords.

Step 8. Installing the HiFD drive device driver

Note: The label on the HiFD installation CD provides instructions on installing the HiFD drive device driver. If you have any problems with the instructions on the CD label, return to the installation instructions in this section.

If the installation program does not start automatically, continue with the next step.

Using the HiFD drive

You can use the HiFD drive and diskettes to:

- Read from and write to 1.44 MB or 720 KB diskettes.
- Conserve hard disk drive space by storing up to 200 MB of data on a HiFD diskette.
- Transport large amounts of information on HiFD diskettes.

- Store multimedia files that require large amounts of storage space.

• HiFD icon

The HiFD icon displays in My Computer after you install the utility software.

HiFD Eject

You can eject a diskette from the HiFD drive by using the right-click button to click the **HiFD** icon and selecting **EJECT** in the pull-down menu. For information on using the emergency diskette eject procedure, refer to "Ejecting a diskette from a HiFD drive" on page 1-25.

• HiFD Copy

You can copy files on a HiFD to the HiFD drive by using the right-click button to click the **HiFD** icon and selecting **Copy Disk** in the pull-down menu.

• HiFD Format

Note: You cannot use the Windows **Format** command to format the HiFD drive or HiFD diskettes.

You can format the HiFD drive or a HiFD diskette by using the right-click button to click the **HiFD** icon and selecting **Format** in the pull-down menu.

Write-protecting HiFD diskettes

HiFD diskettes have a sensing hole so that they can be recognized by HiFD drives. A small insertion-protection indentation prevents you from inserting a HiFD diskette into a non-HiFD diskette drive. You can write-protect a HiFD diskette by pushing up the Write-Protect tab on the diskette.

Ejecting a diskette from a HiFD drive

Attention: You might damage the HiFD drive if you press the Eject button too hard.

If a diskette cannot be ejected with the Eject button, you can use the following emergency eject instructions:

- 1. Turn off the computer and all attached devices.
- 2. Unplug the cables from the power outlets for your computer and all attached devices.
- 3. Remove the system faceplate or cover.
- 4. Straighten a large paper clip to form a tool. The straightened end must extend at least 45 mm (1.8 in.).

5. Insert the extended end into the manual-eject hole on the front of the drive, as shown.



- 6. Push the paper clip until the diskette is ejected.
- 7. Gently remove the diskette.

- 5. Verify that the cable connections on the drive and the computer are secure.
- 6. Be sure that the drive and other devices on the device chain are correctly configured. For more information, see "Step 4. Configuring the drive" on page 1-5.
- 7. Be sure that there are only IDE devices on the device chain.
- Reinstall the HiFD device driver and the utility software. For more information on installing the HiFD software, see "Step 8. Installing the HiFD drive device driver" on page 1-10. For more information on installing the HiFD utility software, see "Using the HiFD utility software" on page 1-12.

You do not see drive A in My Computer (Windows 98, Windows 95 OSR2 or later, and Windows NT).

Take the following actions.

- 1. Check the CMOS configuration for the computer system.
- 2. Turn off the computer, unplug the cables from the electrical outlets for your computer and all attached devices, and remove the computer cover.
- 3. Be sure that the diskette-drive cable is connected to the HiFD drive. For more information, see "Step 6. Connecting the drive and the cables" on page 1-6.
- 4. Verify that the dc power cable is securely connected to the drive. For more information, refer to "Step 6. Connecting the drive and the cables" on page 1-6.

• The computer displays an error message.

Take the following actions.

- 1. Be sure that there are only IDE devices on the device chain and that there is one device configured as a Master and one device configured as a Slave on each IDE cable connected to a computer IDE port.
- 2. You might be using a damaged diskette. Try using another diskette.
