Product description

The IBM® 100/200 GB¹ LTO Internal Tape Drive is a fast/wide Ultra2 (low voltage differential) SCSI tape drive for backing up and restoring data and archiving files. These files can include multimedia, imaging, transaction processing, large databases, and other storage-intensive applications. Each tape cartridge can store up to 100 GB of data (uncompressed), or up to 200 GB of data (compressed), assuming a 2:1 compression ratio.

In addition to this book, the option package contains:

- IBM 100/200 GB LTO Internal Tape Drive
- Mounting screws
- Jumpers
- Data cartridge
- Backup application CDs (trial versions)
- Safety Information manual
- Cleaning cartridge
- Device driver diskette

Contact your place of purchase if an item is missing or damaged. Be sure to retain your proof of purchase and packing material. They might be required to receive warranty service.

Software description

The IBM® 100/200 GB LTO Internal Tape Drive includes trial-version backup application CDs. These CDs contain popular backup and restore applications for Microsoft® Windows NT®, Novell NetWare, and other operating systems. You can install the application you choose for your computer system by following the installation instructions that come with the CD you select. However, these trial versions of the software expire after 30 to 90 days, depending on the application you use.

You can use the trial period to determine the best application for your specific computer configuration. For information on purchasing a permanent installation copy of the desired tape drive backup application, go to the IBM tape drive Web site at

The CDs also contain backup applications that are used with other products but are not applicable to the 100/200 GB LTO Internal Tape Drive. Supported tape drive configurations can be found on the IBM Netfinity® Server Compatibility Web page at http://www.ibm.com/pc/compat

Installation requirements

To install this drive, you must have the following:

- Low voltage differential (Ultra2) or a single-ended (SE)2 SCSI host adaptor.
- Documentation for your computer, SCSI bus adapter, or external enclosure
- An Ultra2 LVD active terminator if you are installing the tape drive at the end of an Ultra2 LVD SCSI device chain3, or an SE active terminator if you are installing the tape drive at the end of an SE SCSI device chain³
- Phillips and flat blade screwdrivers for the mounting screws, and for opening your computer
- Flat-nose pliers (optional) to install and remove jumpers
- An available 5.25-inch full high drive bay

This tape drive can be installed on a single-ended (SE) SCSI device chain, but doing so might limit the performance of the drive.

SCSI termination might be provided with your computer or SCSI adapter. Refer to the documentation that comes with your computer or SCSI adapter for more information.

Installing the drive

This section contains information on installing the tape drive in IBM servers and in other computers.

Installing the drive in IBM servers

The tape drive is compatible with the IBM Netfinity 5500 M20, 5600, 6000R, 7100, 7600, and 8500R possibly other⁴ servers. Refer to the documentation that comes with the server for instructions on installing the tape drive

If you are using a Netfinity 6000R server, you must install the tape drive in a SCSI external storage enclosure such as the IBM 3551-001 or IBM 3503-BOX.

Installing the drive in other computers

Follow these steps to install the tape drive in other computers.

Step 1. Selecting a SCSI ID

Each device on a SCSI bus must have a unique SCSI ID. You can select a SCSI ID from 0 to 6 for the tape drive. The SCSI ID must be supported by your SCSI adapter. Refer to your SCSI adapter documentation for the range and the relative priority of the IDs supported. The tape drive is shipped with the SCSI ID preset to 5.

Follow these guidelines to select a SCSI ID:

- Assign the tape drive to one of the higher priority IDs available (0–6).
- Assign the lower priority ID numbers (8–15) to those devices that are most often used or are faster than other devices in the chain.
- Do not assign an ID of 7, because this is usually used as the SCSI adapter ID.

Depending on your computer, there are several ways to view your current SCSI ID settings:

- For many IBM computers, press F1 during the startup after the memory check completes. Other adapters show SCSI settings when you press Ctrl+A. Check the documentation that comes with your computer or SCSI adapter for information on how to view configuration information.
- Use SCSI adapter utility programs, if available.
- Inspect the installed SCSI devices to see how the jumpers that determine the IDs are set.

Step 2. Preparing for installation

To prepare for installation:


- 1. Unpack the tape drive and store the packaging. You will need the packaging if you return the drive for service.
- If you are installing the drive in an external storage enclosure, turn off the enclosure.
- 3. Turn off all attached devices.
- 4. Turn off the computer.
- Disconnect all cords from the computer and all attached devices; then open the computer. For specific information on opening your computer, refer to the documentation that comes with your computer.

Attention: Tape drives are sensitive to static electricity discharge. The drives are wrapped in a static-protective bag to prevent damage.

6. Before opening the static-protective bag containing the tape drive, touch the bag to an unpainted metal surface on the computer for at least two seconds. Remove the drive from the static-protective bag. If you must put the drive down, place the drive on the static-protective bag. Do not touch any exposed components of the tape drive. Instead, handle it carefully by the edges.

Step 3. Setting the SCSI ID

Refer to the following diagram when setting the SCSI ID.



- 1 SCSI connector
- 2 SCSI ID connector
- 3 Power connector


Notes:

- 1. When setting the SCSI ID, use the jumpers that come with the tape drive.
- 2. If your enclosure uses a remote SCSI ID switch, remove the jumpers from the jumper pins on the tape drive and connect the remote switch.

1. Set the SCSI ID.

- a. Locate the SCSI ID connector 2.
- b. Decide on the SCSI ID number you want before you attach the SCSI bus cable to the host. Make sure that the ID number you want is not already being used by another device.
- c. Find the jumper pin setting that corresponds to the SCSI ID number you choose; then place jumper pins on the SCSI ID blocks as shown. You can use a pair of flat-nose pliers to place the jumpers on the jumper pins.



2. Terminate the SCSI bus.

If the drive is the last device on the SCSI bus, you must terminate the drive.

To terminate the bus internally, locate one of the jumpers shipped with the $100/200~\mathrm{GB}$ LTO Internal Tape Drive and place it on the SCSI ID connector as shown.




Step 4. Mounting the drive

Mount the tape drive; then attach the SCSI and power cables to it. If there is insufficient working space to attach the connectors after mounting the drive, attach the cables first. To mount the drive, follow these steps:

- Locate an available 5.25-inch bay or space in your computer to mount the tape drive. Remove the cover plate from the bay selected. Place the drive horizontally or vertically.
- 2. Align the drive-bay screw holes with the threaded holes in the drive housing. When you mount the tape drive, follow these guidelines:
 - Ensure that no objects such as screw heads, cables, or adjacent devices are pressing against the frame.
 - Ensure that nothing blocks the ventilation slots on the bottom and rear of the tape drive.

3. Insert a screw through each of the drive-bay holes into the threaded holes in the drive and tighten the screws with a screwdriver. Use only the screws that come with the tape drive. Other screws might be too long and cause electrical shorts.

Step 5. Attaching cables



The rear tape drive connections are:

- 1 SCSI cable connector
- 2 Power connector

To attach the SCSI and power cables to the tape drive:

 Locate the SCSI cable on your computer (a 68-pin ribbon cable with one end connected to the SCSI adapter) and find the next available connector that is farthest from the adapter. Use all empty bus connectors beginning with the one farthest from the adapter to ensure better signal quality.

Note: The SCSI adapter might be part of the computer system board or might be an adapter installed in an expansion slot.

2. Attach the SCSI cable from your computer to the tape drive 68-pin SCSI connector 1. The SCSI cable connector at the end of the SCSI cable will attach to the drive only one way. Do not force the cable onto the drive.

Attention: Do not force the power cable into the tape drive power connector. If the power cable is upside down and you force the connection, you might damage the drive.

3. Connect the power cable connector to the four-pin connector **2** on the tape drive as shown in the illustration. If all the power cables are in use, purchase a dc Y-splitter cable, which is available at most electronics stores, and split a connection to make a connection available for the tape drive.

Step 6. Completing the installation

Check your work before closing the computer.

- 1. Be sure that the power and SCSI connectors are securely attached. Be sure that the cables are neatly routed.
- Replace the computer cover and secure it in place. Reconnect the power cords and cables.

Step 7. Turning on the device

Turn on all attached devices; then turn on your computer. The tape drive performs a power-on self-test (POST) within 15 seconds and then performs a drive reset.

Step 8. Updating the configuration

For most computers, the configuration-setup utility program automatically recognizes the new tape drive. However, you might have to provide information about your system changes after you restart your computer.

Ensure that the appropriate advanced SCSI programming interface (ASPI) device drivers are installed to support the tape drive. Device drivers are usually provided with the SCSI adapter.

If your computer does not recognize the tape drive after startup or if you receive startup errors, run the configuration-setup utility program as described in the documentation that comes with your computer.


If all the indicators on either side of the tape drive blink in unison, there is a problem with the tape drive. Press the **Unload** button on the right side of the drive front panel to eject any tape that might be inserted and to reset the drive. If the problem persists, turn off the computer; then turn it back on. If the problem continues, see Appendix E, "Problem solving" on page 2-10 for further steps.

Step 9. Installing backup and restore software

To use the drive, you must install an appropriate backup and restore application for your computer operating system. If you are using software not included in the option package, follow the directions that come with your software. If you are using the trial software that comes with the option, insert a trial application CD into the CD-ROM drive and follow the on-screen installation and operating instructions.

Using the drive

This is the front of the 100/200 GB LTO Internal Tape Drive



The following tables describe the indicators on the drive front panel.

Status indicator 1. This indicator provides status information on the tape drive.

Indicator activity	Meaning
Off	The tape drive is idle or turned off.
Green, shining steadily	The tape drive is reading from or writing to the tape.
Green, flashing	The tape drive is rewinding the tape, locating data on the tape, or unloading the tape.
Yellow, shining steadily	The tape drive is in maintenance mode.
Yellow, flashing	This indicates one of the following:
	 If the indicator flashes one time per second, an error has occurred and the tape drive or the media might need service. Check the display panel for the error code. If the indicator flashes two times per second, the tape drive is updating the microcode. If the indicator flashes four times per second, the tape drive detected an error and is performing a microcode recovery. The tape drive will automatically reset.

Unload button 2 . This button unloads tape and issues commands.

Function	How to use the Unload button to perform the function
Rewind the tape in a cartridge and unload the cartridge from the tape unit	Press the Unload button one time. Note: During a rewind and unload operation, the tape drive will not respond to SCSI commands from the host adapter.
Place the tape drive in maintenance mode	Be sure that there is no cartridge loaded in the tape drive. Within a one-second interval, push the Unload button three times. The status light will flash steadily and the display panel will display 0 to indicate that the tape drive is in maintenance mode. Note: During a rewind and unload operation, the tape drivewill not respond to SCSI commands from the host adapter.
Scroll through maintenance functions	Using the instructions in the previous row, place the tape drive in maintenance mode. In maintenance mode, press the Unload button one time per second to increment the display characters by one digit. When the diagnostic or maintenance function character displays, press and hold the Unload button for two seconds.
Exit maintenance mode	Press the Unload button one time per second until 0 displays in the display panel. Press and hold the Unload button for two seconds. The status indicator stops lighting, the display panel reads 0and then goes black when the tape drive discontinues maintenance mode.

Function	How to use the Unload button to perform the function
This indicator displays letters and numbers, each indicating different drive messages.	Use the table in Appendix C, "Self test sequence settings" on page 2-4 to determine the meaning of the display panel messages.


Loading tape cartridges

To load a tape cartridge, perform the following steps.

- 1. Make sure the tape drive is turned on.
- 2. Make sure the write-protection switch on the tape cartridge is properly set. See "Setting write protection on the cartridge" on page 1-10.
- 3. Grasp the tape cartridge so that the **1** write-protect switch faces you.
- 4. Slide the tape cartridge into the tape load compartment.

Note: If the tape cartridge is already in the unload position (partially ejected) and you want to reload it, remove the cartridge and then load it again.

If the the tape cartridge is already loaded and you turn the power off, then turn the power back on, the tape cartridge will reload.




Unloading tape cartridges

To unload a tape cartridge, perform the following steps.

- 1. Make sure that the 100/200 GB LTO Internal Tape Drive is turned on.
- 2. Press the Unload button. The drive rewinds the tape and places the tape cartridge in the unload position. The status light will flash green while the tape rewinds, and go out before the cartridge reaches the unload position.
- After the tape cartridge has reached the unload position, grasp the cartridge and remove it.

Setting write protection on the cartridge



The front of the cartridge has an orange write-protect indicator 1, and a write-protect switch 2 to prevent accidental erasure. Slide the switch to the right to write-enable 3 or to the left to write-protect 4. You can change the write-protect switch before or after inserting the tape. If you change the write-protect switch while the tape is inserted, there is a delay of a few seconds before the Write Protect indicator on the tape drive changes.

Resetting the drive

The reset procedure rewinds the tape and clears the buffer of previous tape drive commands and data. To reset the tape drive, press the Unload button, or turn the computer off and back on again.

If you reset the tape drive while a cartridge is loaded, the tape rewinds to the beginning. The reset might take as long as two minutes if the tape is positioned near the end. After the drive has been reset, tape operation starts from the beginning of the data cartridge. After resetting the drive, restart your backup tape software.

Packing the drive for shipping

If you are shipping the tape drive to another location or returning it for repair, pack the tape drive in its original shipping container and packing materials.

Attention: To avoid damaging the tape drive, use the original shipping materials when you ship it. Your proof of purchase might be required to receive warranty service. If you are returning the tape drive for service, remove and keep all cartridges, cables, and terminators.

Part 2: Appendixes

The following appendixes contain product specifications, problem-solving information, help and service information, the product warranty, and notices.

Appendix A. Maintenance

You need to perform regular maintenance on your 100/200 GB LTO Internal Tape Drive. This section explains how to care for the tape cartridges and how to clean the drive head.

Caring for tape cartridges

The following points are guidelines for storing and using the cartridges:

- Do not open the tape access door of the cartridge or touch the tape itself.
- Keep your cartridges away from sources of electromagnetic fields, such as
 telephones, dictation equipment, mechanical or printing calculators, motors, and
 bulk erasers. Do not place the cartridges on the computer monitor or on the base
 unit of the computer.
- Keep cartridges away from direct sunlight and heat sources, such as radiators or warm air ducts.
- Keep cartridges free of moisture. Do not wet or submerge cartridges in any liquid.
- Do not expose cartridges to temperature extremes.
- Retensioning is the winding and rewinding of a tape cartridge. This action
 restores the proper tape tension to the media. Retension tape cartridges that have
 not been used for more than a month before restoring or backing up data. It is
 recommended that you retension regularly used data cartridge once per week.
 Instructions for performing a manual tape retensioning are available in your
 backup application user's guide.

Cleaning the tape head

To properly maintain the drive, periodically clean the tape head. Clean the tape drive after using a new data cartridge. If you backup your data daily, clean the tape drive once a week. You do not need to perform any other periodic maintenance. Use a dry process cleaning cartridge by IBM (P/N 6G8583) or Imation (P/N 0-5122-12132-6), which can be obtained from your local reseller.

To clean the tape drive, wait until the tape drive has stopped any activity and follow these steps:

- 1. Remove any cartridges from the tape drive.
- 2. Insert the cleaning cartridge into the tape drive The drive light will start flashing, indicating that the cleaning process is working.

- 3. When the drive light stops flashing, the cleaning process has finished.
- 4. Remove the cleaning cartridge from the tape drive.

Replace the cleaning cartridge after 30 cleaning operations.

Fault diagnosis

If an error occurs with the tape drive, follow these steps to eliminate possible causes.

Note: After each step, retry the backup operation. If the backup still fails, go on to the next step.

- Clean the tape drive.
- Retension the data cartridge.
- Replace your data cartridge.
- Go to the IBM support Web site at http://www.ibm.com/pc/support

Appendix B. Tape handling

This section describes how to properly handle your tape cartridges to reduce wear on the 100/200~GB LTO Internal Tape Drive

Tape handling and storage

Most tape is supplied in a sealed cartridge. Tape is provided this way so that the tape will remain in a clean environment. Opening the cartridge allows dirt and airborne particles to enter and then become a source of contamination. The cartridge must only be opened by the tape drive and not by an operator. The tape is also held under proper tension inside the cartridge. If the cartridge is dropped, this tension is relaxed. Inserting a dropped cartridge into a tape drive can often cause a misload that results in a jam. The jam ruins the tape and can cause physical damage if the cartridge is not removed properly. When you store tapes, place them into their protective containers and store them on their ends. Store the tapes in a clean, dry area at normal room temperature and away from magnetic fields.

Environmental issue

The operating environment might adversely affect tape drive operation. The tape drive is designed to operate in a clean environment. When tape is installed in a tape drive, the clearance between the heads and the tape is measured in microns. Even particles of smoke are larger than the space available between the tape and the heads. Other environmental factors that adversely affect tape drive operation are dirt, dust, fibers, and airborne particles.

Tape drive cleaning

Even if the operating environment is clean, dirt might build up on the heads of any tape drive. Every time tape motion occurs, some of the media surface comes off on the heads. Over time, this material builds up, causing the tape head clearance to increase. The increased tape head clearance produces reading and writing errors. Most tape drives today have a built-in cleaning indicator to notify you when the tape needs cleaning.

Do not use any non-LTO cleaning cartridges with these tape drives. You can use cleaning cartridges only for a limited number of times. A cleaning cartridge is expired after it has been used for the maximum number of times. When a cleaning cartridge is expired, you must replace it. Never reuse an expired cleaning cartridge. If you continue to use an expired cleaning cartridge, you might reintroduce previously removed dirt to the tape drive and you might not clean the drive. To make sure that you know when your cleaning cartridge expires, make a notation on the cleaning cartridge each time you clean the tape drive.

Appendix C. Self test sequence settings

To perform the diagnostics listed in Appendix C, "Self test sequence settings," the 100/200 GB LTO Internal Tape Drive must be placed in maintenance mode. To place the drive in maintenance mode, perform the following steps.

Placing the drive in maintenance mode

- 1. Verify that no tape cartridge is in the drive.
- 2. Make sure no backup software is running, or about to run.
- 3. Within a one-second interval, press the unload button 3 times. The status light shines yellow, indicating that the unit is in maintenance mode.

Note: If a tape cartridge is in the drive, it will eject the first time you press the unload button, and the drive will not be placed in maintenance mode.

Maintenance functions cannot be performed concurrently with read or write operations. While in maintenance mode, the drive does not receive SCSI commands from the host.

Selecting maintenance and diagnostic functions

To select a maintenance or diagnostic function, perform the following steps.

- Make sure the drive is in maintenance mode (see "Placing the drive in maintenance mode").
- Locate the number code for the function you wish to perform. See the table "Diagnostic and maintenance functions" on page 2-5 for the complete list of maintenance and diagnostic functions.
- Press the unload button once per second until the code that corresponds with the maintenance or diagnostic function you wish to perform appears in single-character display.

Note: If you cycle past the desired code, continue pressing the unload button once per second until the code you want redisplays.

- 4. When the code for the function you wish to perform is displayed in the single-character display, press and hold the unload button for two seconds. The drive will begin to perform the maintenance or diagnostic function you selected.
 - During and after the performance of certain maintenance functions, the drive might display certain characters, or the drive status light might flash.
 - Refer to the following table to learn the meaning of these messages.

Diagnostic and maintenance messages

Symbol	Meaning	Action


