#### 1 Preface

This White Paper explains how to use IBM® Remote Deployment Manager (RDM) 4.20 (or a later RDM version) to update Diagnostics firmware.

There are other ways to flash Diagnostics firmware (e.g., with the BIOS and Diagnostics firmware diskettes, with the UpdateXpress CD, etc.). But using RDM to do this from a remote console on many systems concurrently, without having to visit the systems, is a powerful and easy way to accomplish this task.

You can use this White Paper to learn how to do the following:

- Updating Diagnostics firmware on systems that use the FLASH2.EXE program to update their BIOS and Diagnostics firmware.
- Updating Diagnostics firmware on systems that use some other program (i.e., not FLASH2.EXE) to update their BIOS and Diagnostics firmware.

In addition, this White Paper will help you learn some of the typical techniques that you can use to extend and customize RDM:

- Modifying RDM System Firmware Flash tasks.
- Creating RDM Custom tasks.
- Creating RDM custom images and using them in an RDM task.
- Using the RDM Command List Wizard to add an image to an RDM task.
- Use RDAGENT.EXE to display messages in the task log.

The tasks described in this paper accomplish their desired functions in a variety of ways. There are alternate techniques available for doing all of these functions. The intent is to illustrate various methods, as well as to describe a way to implement these particular functions.

This document contains embedded files. Just right click on the paperclip icon in order to extract the embedded files.

One good use of the custom task described below is in an end-to-end deployment procedure (i.e., an RDM Script task that does all steps in deploying a system). For example, such a Script task might contain the following subtasks:

- 1. Customized System Firmware Flash task updates System BIOS, Diagnostics, and Integrated System Management Processor firmware.
- Custom task to update the firmware and BIOS on a ServeRAID adapter (i.e., the task described below).
- Custom task to update disk-drive firmware.
- 4. Custom task to update Diagnostics.
- Custom task to update network adapter firmware.
- RAID Custom Configuration task.
- 7. Task to deploy the operating system and applications one of these:
  - Windows Native Install task.
  - Windows Clone Install task.
  - Linux Native Install task.
- 8. Power Restore task.

9. CMOS Update task - modifies the CMOS/BIOS settings.

#### 1.1 Who should read this White Paper

This White Paper is intended to help skilled RDM administrators to create deployment procedures and to understand the concepts involved. To effectively use this White Paper, you should already have an extensive knowledge of your Network environment, your RDM environment, and DOS batch files.

#### 1.4 Embedded files


For your convenience, we have included the files referenced in this document in an embedded file.

1. Extract the attached self-extracting ZIP file, *DiagnosticsFiles.EXE*, by right clicking on the paperclip icon and saving the file to disk.

**Note:** You may need Adobe Acrobat Reader 6.0.1 or later to be able to extract the file. 
- 2. Run DiagnosticsFiles.EXE.
- 3. Change the target folder name appropriately (e.g., to C:\), and then click the *Unzip* button.



4. Click the OK button when the unzip is complete.



5. Click the Close button to exit WinZip.



- 6. Then you can find the files in the C:\DiagnosticsFiles directory:
  - C:\DiagnosticsFiles\8839\CommandList
  - C:\DiagnosticsFiles\8839\DIAGFW.BAT
  - C:\DiagnosticsFiles\FLASH2\CommandList
  - C:\DiagnosticsFiles\FLASH2\LCREFLSH.BAT

Use the files in C:\DiagnosticsFiles\FLASH2 in chapter 2 below and the files in C:\DiagnosticsFiles\8839 in chapter 3 below.

## 2 Procedure for updating BIOS and Diagnostics

On some systems, the BIOS and Diagnostics firmware are updated with the same program (e.g., FLASH2.EXE). It is possible to create a custom task to update Diagnostics firmware (see section 3 below). However, it might be easier just to add the Diagnostics update to the same task that does the BIOS update (i.e., a System Firmware Flash task).

Like most RDM tasks, this customized System Firmware Flash task contains the following:

- A CommandList file containing the commands that the task executes.
- Executable programs and batch files that the task executes.
- o Parameters (read-only) that can personalize each system.
- RDM System Environments (usually IBM DOS 7.1) that boot via the network.
- An RDM image that is input data for the task.

The steps shown below describe how to create or modify these task parts.

#### 2.1 Acquire Diagnostics and BIOS firmware files

RDM uses diskettes as the source for its BIOS images. This procedure also uses diskettes as the source for its Diagnostics image.

- 1. Download the appropriate files (for your particular target system machine type) from the IBM web site.
- 2. Use those files to create the Diagnostics and BIOS diskettes. There will be 1 or 2 diskettes for Diagnostics firmware and 1 or 2 diskettes for BIOS firmware (depending on the system model).

#### 2.2 Create a System Firmware Flash image of the BIOS

- 3. Use RDM's *Image Management* window in the normal way to create the BIOS image from the BIOS diskettes. It will also be prudent to describe the image, in detail, for future reference:
  - Make the image name reflect that it will contain both BIOS and Diagnostics firmware (e.g., 8832 HS20 BIOS 1.04 and Diagnostics 1.02).
  - You should also add an optional image description.

#### 2.3 Add Diagnostics and batch files to the BIOS image

You will add the Diagnostics firmware and a new batch file that does the flash to the BIOS image. When RDM flashes BIOS, it finds the program that does the flash by the following logic (pseudo code):

If LCREFLSH.BAT exists, then

Run LCREFLSH.BAT to flash the BIOS

Else if FLASH2.EXE exists, then

Run FLASH2.EXE to flash the BIOS

Else

Fail the task with a message indicating that RDM found no flash program

#### Endif

This task capitalizes on that logic and uses an LCREFLSH.BAT file to do the flash of both BIOS and Diagnostics firmware.

- 4. If you created the BIOS image with RDM 4.11 or RDM 4.1, rename the BIOS image file by adding an extension of ZIP (e.g., 1728374697.ZIP). If you created the BIOS image with RDM 4.20, its file will already contain the ZIP extension, so do not change the file name.
- 5. Using any program that can modify ZIP files (e.g., WINZIP.EXE), add the 2 large files (the actual file names depend on the machine type of the target system) from the Diagnostics diskettes to the ZIP file. Make sure that you do not save path information when you add the files to the ZIP file.
- 6. If the BIOS image uses FLASH2.EXE, you should create an LCREFLSH.BAT file containing the following statements and add it to the ZIP file. You can extract a copy of this file from the embedded file in section 1.4 above.

7. Close the ZIP program.

#### 2.4 Create a new System Firmware Flash task

This step is optional, but highly recommended.

- 8. Create a new System Firmware Flash task in the normal way. It will also be prudent to describe the task, in detail, for future reference:
  - Make the task name reflect that it will contain both BIOS and Diagnostics firmware (e.g., 8832 HS20 BIOS 1.04 and Diagnostics 1.02).
  - You should also add an optional task description.
- 9. Select the image that you modified in section 2.3.
- 10. Save the new task by selecting the **OK** button.

#### 2.5 Test the BIOS/Diagnostics image

- 11. Run a System Firmware Flash task, such as the task you created in section 2.4 or the built-in *Deploy latest system firmware task*, to validate that the BIOS and Diagnostics updates work.
- 12. Immediately after the **Starting PC DOS...** message appears on the target system's monitor, press the F8 key. This allows you to step through all of the batch files, statement-by-statement.
- 13. Press the "y" key to execute each statement, in-turn. Observe each statement, and watch for any errors that may occur.

**Note:** If an error occurs, debug it, fix it as appropriate (usually in one of the files you created or modified above), and then rerun the test.

To rerun a failed test, you may need to do the following:

- a. Power off the target system with the power switch.
- Right-click on the target system in the middle pane.
- c. Click the **Remote Deployment Manager** and the **Cancel Tasks** menu items.
- d. Go back to step 11 above.

## 3 Procedure for updating Diagnostics only

The Custom task template is a general-purpose template that you use to create your own processes to run on a target system. This example contains 4 of the 5 basic parts of an RDM task:

- A CommandList file containing the commands that the task executes.
- Executable programs and batch files that the task executes.
- o RDM System Environments (usually IBM DOS 7.1) that boot via the network.
- An RDM image that is input data for the task.

Note that this example does not have the following:

Parameters that can personalize each system.

This example creates a Custom flash task for updating Diagnostics firmware on model 8839 BladeCenter HS20 blades. The task will deploy a specific firmware level on a target system of a specific machine type. You must create a Custom task like this one for each firmware level and machine type.

#### 3.1 Acquire Diagnostics firmware files


This procedure also uses diskettes as the source for its Diagnostics image.

1. Download the appropriate files from the IBM web site, and create the 1 or 2 Diagnostics diskettes.


#### 3.2 Create a Custom image of the Diagnostics firmware

Use RDM's *Image Management* function to create the custom image. This stores the firmware in the RDM master repository and adds metadata about the image into the RDM database.


2. In the IBM Director console, click the **Tasks...Remote Deployment Manager...Image Management...Create and Modify Images** menus to open the *Image Management* window.




3. Click the Create... button to open the Create Image window.




- 4. From the drop-down list, select **Custom**; then select the **OK** button to open the *Create Custom Image* window. There are 2 pages:
  - **General**: Contains basic information about the image.
  - **Setup**: Contains the definition of the input data that you use to create the image file and the configuration of the output image.
- 5. On the General page, enter a name for the image and (optionally) a description.




6. On the Setup page, in the *Input* area, select **Multi-volume**, **removable media**. In the *Output* area, select the **File** radio button.



7. Select the **Browse** button, navigate to A:\, and select the **OK** button.




- 8. Put diskette 1 in your A: drive.
- 9. Click the **OK** button on the *Create Custom Image* window to copy files from the first diskette. You will see a progress-indicator window, followed by a message window.






10. Put diskette 2 in your A: drive, and select the **OK** button on the message window. This will copy files from the second diskette. You will again see the progress-indicator window, followed by the message window.

11. Click the **Done** button. You will see an *Image Creation Messages* window describing duplicate files. These are not errors, so click the OK button.



The new custom image will appear in the *Image Management* window.



#### 3.3 Create a batch file that will do the flash update

It is common to incorporate some of the task logic in a batch file that the task's command list will call. This facilitates error handling, so that you can make the task fail whenever some part of its logic fails.

12. Using your favorite editor (e.g., Notepad), create a file named C:\DIAGFW.BAT that contains the following statements. You can extract a copy of this file from the embedded file in section 1.4 above.

ECHO Entering DIAGFW.BAT
SET RDSTATUS=RDMDFW0001
SET RDRASLEVEL=0

RDAGENT /L "Merging firmware files."


Notice that AFUIDOS is the program that updates the Diagnostics firmware. It is contained in the image that you created in section 3.2 above. This sample batch file is for the BladeCenter HS40 model 8839 blade computer. If you are creating a custom task to flash diagnostics of a different machine type, you will have to adjust C:\DIAGFW.BAT accordingly.

Also notice the error handling in this batch file. At the beginning of the file, it initializes 2 of RDM's reserved environment variables to values that indicate "success". If AFUIDOS fails *and if it sets a non-zero ERRORLEVEL*, the SET statements after label FLSHERR change the environment variables' values to indicate "failure". In particular, because the 10<sup>th</sup> character in RDSTATUS is "E", the RDM task that uses this batch file will fail and display that error message in its task execution history.


#### 3.4 Create the Custom task that will deploy the firmware

Because RDM does not have any built-in logic to flash Diagnostics firmware, this procedure uses a Custom task.

13. Expand **Remote Deployment Manger** in the *Tasks* pane of the IBM Director console, and right-click **Custom**. The menu is displayed.




- 14. Click Create new task... on the menu to access the property pages. There are two pages:
  - General: Contains basic information about the task.
  - Advanced: Contains the command list, user parameters, and task folder name for the task.




- 15. Enter the task information on the General page (e.g., name the task *HS40/8839 diagnostics firmware update*, and enter an optional description of the task).
- 16. Click the **Advanced** tab, and modify the command list this way. You can extract a copy of this file from the embedded file in section 1.4 above.:


**Note:** The command list is a list of RDM and DOS commands that are the Custom task logic. Refer to Appendix A, "Command list commands", in the *Remote Deployment Manager 4.30 User's Reference* for information on commands and syntax within a command list.




17. Place the cursor on the blank line (see the picture, above), and select the **Insert** button. The *Command List Editor Wizard* window appears.



18. Select the custom image that you created in step 3.2 above, and then select the **Next** button.



- 19. Enter the appropriate data to generate the correct commands to download and unzip the custom image you created in section 3.2 above:
  - Select DOS as the target operating system.
  - Leave the transfer mode as Unicast.
  - o Add an optional comment, if you like.
  - Enter the path and name that you want the image file to have on the target system.
  - Select the check box to generate an unzip command, and enter the path for the unzipped files.
- 20. Select the *Finish* button to add the generated commands to the command list.



21. Click the **OK** button to create the task.

#### 3.5 Copy files into the task folder

When creating a custom task (or modifying any task), you must choose where to store the files that the task will use. In this case, we choose the task folder, because the batch file is specific to this task. A side benefit of doing this is that the file will never be deleted or changed by a future RDM update.


- 22. Edit the task you just created.
- 23. Select the Advanced tab.
- 24. Select the **Task folder** category. Make a note of the task folder name: C:\Program Files\IBM\RDM\repository\template\3\546
- 25. Copy the file that you created in section 3.3 above into the task folder:

COPY C:\DIAGFW.BAT C:\Progra~1\IBM\RDM\repository\template\3\546

#### 3.6 Test the new custom task


26. Power on a model 8839 BladeCenter server in a way that forces a network boot. RDM will run its Scan task on the system and power it off. The system will appear in the middle pane of a Director console.

**Note**: Skip this step if you have previously discovered the system and run an RDM Scan task on the system.



27. Drag the entry for that system and drop it on the new *8839 BIOS/Diagnostics firmware update* task in the right pane. The menu appears. Click **Run systems** ... in the menu. A message window appears.

**Note**: You could, instead, drag the task and drop it on the system – the Director/RDM drag/drop operation works the same way in either direction.




- 28. Click the **Execute now** button. The target system will wake up (i.e., automatically power itself on) and do a network boot.
- 29. Immediately after the **Starting PC DOS...** message appears on the system's monitor, press the F8 key. This allows you to step through all of the batch files and the CommandList file statement-by-statement.
- 30. Press the "y" key to execute each statement in-turn. Observe each statement, and watch for any errors that may occur.

**Note:** If an error occurs, debug it, fix it as appropriate (usually in one of the files you created or modified above), and then rerun the test.

To rerun the test, you will usually need to do the following:

- e. Power off the server with the power switch.
- f. Right-click on the server in the middle pane.
- g. Click the Remote Deployment Manager and the Cancel Tasks menu items.
- h. Go back to step 27 above.



#### 3.7 Create other task instances

If you need to flash diagnostics on more than one kind of target system, or if you need to flash a different diagnostics level, then you must create another task. The easiest way to do that is to copy the task you just created and make some simple changes.

- 31. Create another Custom image for your new Diagnostics firmware. Use the procedure in section 3.2 above.
- 32. In the *Tasks* pane of the IBM Director console, right click on the previous custom task. Select **Copy** task... from the menu.
- 33. Enter a name and optional description for the new task.
- 34. Make the changes required to make the new task do what you want.
- 35. Test your new task. Use the procedure in section 3.6 above.

## 5 Glossary

**BAT file**. A file that contains a batch program (that is, a set of commands).

**bind**. Associating one or more systems to a task. This causes all information to be verified (by one of the STC modules) and a resulting job to be scheduled to run.

**console, or RDM Console.** The group of programs that make up the user interface to RDM. RDM is client/server in nature so that the Console might run on any computer and not necessarily be running on the same computer as the RDM server or other RDM components. The RDM Console is actually an IBM Director Console on which the RDM Console component is installed.

**image**. An image is the software stored on a deployment server that is downloaded to a system during an operation. Images vary in size and in the type of software they provide to the system. The purpose and content of each image depends on the task to be accomplished, as well as the method used to download the image from the deployment server to the system. A *native* image is built off a product installation CD. A *clone* image is copied from a donor system.

**job**. An object managed by the scheduler and created by STC. A job is a binding of one task and one or more systems. A job can be scheduled to run once or to recur. Sometimes a job is called by a different name (Scheduled Task, Running Task), to emphasize some aspect of the job.

**managed system**. The IBM Director term for its system. Mentioned here only for clarity; the term *system* is preferred when referring to an RDM system.

**preboot DOS agent**. The preboot DOS agent is a DOS operating system with a communications stack that is booted from the network by the bootstrap agent. The preboot DOS agent performs actions on a system as directed by the RDM server.

**Preboot Execution Environment (PXE).** PXE is an industry standard client/server interface that allows networked computers that are not yet loaded with an operating system to be configured and booted remotely. PXE is based on Dynamic Host Configuration Protocol (DHCP). Using the PXE protocol, clients can request configuration parameter values and startable images from the server.

The PXE process consists of the system initiating the protocol by broadcasting a DHCPREQUEST containing an extension that identifies the request as coming from a client that uses PXE. The server sends the client a list of boot servers that contain the operating systems available. The client then selects and discovers a boot server and receives the name of the executable file on the chosen boot server. The client downloads the file using Trivial File Transfer Protocol (TFTP) and executes it, which loads the operating system.

Redundant Array of Independent Disks (RAID). RAID is way of storing the same data in different places (thus, redundantly) on multiple hard disks. By placing data on multiple disks, I/O operations can overlap in a balanced way, improving performance. Multiple disks increase the mean time between failure (MTBF) and storing data redundantly increases fault-tolerance.

**system**. An individual, target system being deployed or managed by RDM. In IBM Director terminology, an RDM system is always a platform managed object. These can represent any of the supported-by-RDM systems. They cannot represent an IBM Director object that RDM does not process, such as a chassis or an SNMP object.

**task**. An already defined and configured unit of work that is available to be applied to a system or a group (of systems). You create a task by clicking on the applicable task template from the RDM main console. RDM is installed with predefined tasks, such as data disposal and scan.

**task template**. A prototype of a specific kind of RDM task. This is a term used to describe the different kinds of tasks shown on the task pane in the main window of the RDM console. Each task template has its own characteristics and attributes. RDM comes with a set of task templates.

**Wake on LAN**. Technology developed by IBM that allows LAN administrators to remotely power up systems. The following components are essential for the Wake on LAN setup:

- Wake on LAN-enabled network interface card (NIC).
- Power supply that is Wake on LAN-enabled.
- Cable which connects NIC and power supply.
- Software that can send a magic packet to the system.

If the system has the first three of the previous components, the system is called a Wake on LAN-enabled system. Even though a system might be powered off, the NIC keeps receiving power from the system power supply to keep it alive. A network administrator sends a magic packet to the system through some software, for example, RDM or Netfinity IBM Director. The NIC on the system detects the magic packet and sends a signal to the power supply to turn it on. This process is also called *waking up the system*. Using RDM, this process can be scheduled for individual systems. The Wake on LAN feature and RDM together make it very easy for you to deploy software on individual systems on a scheduled basis.
